Mr. Chairman and honorable members of this distinguished committee, I am honored to be here today. To have been selected by the President of the United States for this important position is a great honor and I shall endeavor to live up to all the

trust and expectations of those who are a part of this process.

I am deeply concerned about the problems of our society that affect children, youth, and families. If the problems of child abuse, drug abuse, pre-marital sex, idle youth, unemployment, ignorance, and hopelessness are not checked today, the penalty for delayed attention will be enormous tomorrow. What we invest in our children today will be the foundation of our society tomorrow. Since it would be unwise for any builder to put all his resources into a foundation, with our limited resources, we must find ways to do more for less. I pledge today to never limit my resources of time and talents in seeking to achieve the objective of not just more for less but much more for less. Improved management systems, elimination of waste, utilization of volunteer groups, civic, social, and corporate America can make a significant difference.

I promise my full cooperation with this body as I serve the President of the United States and the citizens of this the greatest country on the face of the earth.

The CHAIRMAN. We are meeting this morning to consider the nomination of Clarence E. Hodges. I understand Senator Lugar would like to introduce Mr. Hodges to the committee. Also we want the record to show that Mr. Hodges is accompanied by his brother, Leonard Hodges.

We are pleased to have you here, Leonard.

Senator Lugar.

Senator Lugar. It is indeed a very great pleasure this morning to introduce to this committee Clarence Hodges, who has been a longtime friend and associate of mine. Clarence came to Indianapolis in the 1970's as a part of my administration as mayor of Indianapolis. He was absolutely indispensible in working through vital community efforts. He had very strong rapport not only with the black community, but more importantly as a unifying factor for all citizens of our city during a very crucial period of time.

Because of that work, I asked him to be the deputy director of my Indiana office when I was elected to the U.S. Senate, and he served in that capacity from the beginning of my term in 1977 until this year, when he was appointed to the Community Services

Administration.

He is now seeking a position, and comes before this committee for confirmation, for the Chief of the Children's Bureau in the Department of Health and Human Services, and also for additional

duties in that capacity.

I commend him to the committee with wholehearted enthusiam. He has throughout the State of Indiana not only established rapport with people with compassionate causes, but indeed, as deputy director to Michael Carroll in our Indiana office, established these ties throughout the State with people of goodwill in all respects.

I know that he will do an outstanding job in this new nomina-

tion.

The CHAIRMAN. I want to thank you, Senator Lugar.

I want to say, Clarence, that you have attracted quite a crowd. In fact, there are people waiting in the hall. Had I known that this position would attract so much attention, I would have had the televisions here.

In any event, we are pleased to have you here, and we are pleased to have the introduction by Senator Lugar. You have been nominated by the President to become Commissioner, Administration for Children, Youth, and Families, Department of Health and

Human Services, and the Chief of the Children's Bureau.

As Senator Lugar has indicated, Mr. Hodges comes to us having been confirmed by the U.S. Senate last summer as the Assistant Director of the Community Services Administration, and Director of the Office of Community Action. He served in that position from June to October of this year. As has been indicated, prior to that he was the administrative assistant to Senator Lugar.

Mr. Hodges has extensive experience with programs dealing with children, youth, and families, having served as Director of Human Resources for the city of Indianapolis from 1973 to 1977. In this important position, he was responsible for programs like Model Cities, Youth Commission, Manpower Commission, and the Office of

Youth Development Programs.

Mr. Hodges' most recent appointment has been as a consultant

to the Department of Commerce.

I would ask, Mr. Hodges, have you discussed possible conflicts of

interest with the committee's chief counsel, Mr. Lighthizer?

Mr. Hodges. Yes, sir, I have had such discussions, and he has assured me, along with counsel for HHS, that there are no conflicts of interest.

The CHAIRMAN. Is there any reason that you know of that you cannot responsibly serve in the office to which you have been nominated?

Mr. Hodges. There are no reasons whatsoever that would keep

me from serving in this office.

The CHAIRMAN. There have been concerns voiced in the past that programs dealing with children and families frequently overlap one another, yet still miss providing services for some truly needy individuals. Do you have any methods in mind of how we approach this problem: Prevent the overlapping and still provide the services?

Mr. Hodges. Mr. Chairman, I am convinced that there is some unnecessary overlap and duplication. There is some waste that improved management systems, that improved and expanded involvement of the private sector, the utilization of all the resources of volunteer organizations and associations, the various groups in this country that have a great interest in the children, youth, and families of this country, I am confident that we can pull all these resources together, and do more for less.

The CHAIRMAN. Also the administration's plans, especially those relating to the block grants, seem to restore the States to a full partnership in the planning and administration of programs. The Federal role, in many cases, will become one of support and consul-

tation in response to State and local needs.

Have you given any thought on how the Federal Government can be of most assistance to States and local areas as we get into

the block grant program?

Mr. Hodges. I think, first of all, we would have to deliberate and confer with the leadership of all the States involved to make sure that we are providing services that they desire. That we are making available to the various States, the Governors, their execu-

tives with these responsibilities, the benefit of the knowledge that we have collected on a national basis as a result of studies, and the kind of technical assistance that can be given, and the kinds of opportunities to develop demonstrations and to develop new approaches to some of these problems. Making these resources available to all the States, I am confident, will help the States to do a better job than has been done to date.

The Chairman. I thank you for those responses, Mr. Hodges. I would like to make a part of the record your résumé, and also the letter from the Office of Government Ethics indicating there is no conflict.

We thank you for coming. Leonard, we thank you. Senator

Lugar, we thank you.

Mr. Hodges. Thank you very much, Mr. Chairman.

The CHAIRMAN. While Senator Moynihan is here. Would you object if we would report out the nomination of Clarence Hodges to be Director of the Children's Bureau. We have had the hearing this morning, and there is no opposition. We will poll it out, but I would want to make the motion while you are here.

Senator Moynihan. I thought that that been abolished, the

Children's Bureau.

Why should we have a head of a bureau that has no program? The CHAIRMAN. We still have the Chief of the Children's Bureau, he has not been abolished.

Senator Moynihan. I see. It is a big reward to the faithful.

The CHAIRMAN. It is a rather lengthy title. He is the Commissioner, Administration for Children, Youth, and Families, Department of Health and Human Services, and Chief of the Children's Bureau. It was rather impressive, and he had a big crowd when he was here earlier. [General laughter.]

A lot of them stayed over for this hearing.

Senator Moynihan. I move that the nomination be reported out with the expressed hope of the committee that the Bureau not be abolished.

The CHAIRMAN. He told me that he would be the first to know if that happened. I will keep in close touch with Clarence, and if I hear from him, I will contact you.

This hearing has ended.

Mr. Chairman and distinguished members of the Committee, I appreciate the opportunity to speak on behalf of Clarence E. Hodges, a fellow Hoosier who I am pleased to introduce to this Committee for its consideration.

Clarence's experience in the field of human services is both extensive and impressive. He, as you know, was appointed by President Reagan to be the Assistant Director of the Community Services Administration.
