In this senior management and policy position, I was directly involved in the decision-making process relating to the Administration's overall drug abuse policy and was the Administration's chief liaison representative to the Congress on drug abuse matters.

6/71 - 1/81 - Committee on Ways and Means, U. S. House of Representatives, Washington, D.C., Minority Counsel and Staff Director. Assistant Minority Counsel 1972 - 1974. As Chief Republican staff person on the committee, I managed and was solely responsible for a staff of 17 professional and clerical employees which provided the 12 GOP Committee Members with legal, policy, technical and political counsel on economic policy, capital formation; individual, corporate and foreign taxation; foreign trade; energy; social security, welfare, medicare and national health insurance and unemployment compensation. I was also a Congressional Delegate to the Multi-Lateral Trade Negotiations (MTN) in Geneva, Switzerland.

1/81 - Present - The LTV Corporation, Washington, D.C., Vice President - Government Relations. As the LTV Corporate Officer in charge of government relations, I am responsible for directing all of LTV's activities and programs with federal, state, and local governments. With a staff of five, I manage the issues of importance to LTV's three businesses -- steel, aerospace and energy -- and am the company's principal Washington liaison to the Congress, the Executive Branch, and interest groups. Although my responsibility includes all legislative areas impacting on LTV, my own focus is on taxation, trade and anti-trust. Also, I chair LTV's Political Action Committee. In 1983, I founded and became Chairman of the Basic Industries Coalition, Inc. (BIC), a trade association of twenty-five corporations and trade groups concerned about tax, trade and capital formation issues.

Committee on Ways & Means and the Senate Finance Committee. If requested,

14. Prior to joining The LTV Corporation in 1981, I spent 16 years in  
government service - all of it connected either directly or indirectly  
with the legislative process. As a legislative assistant, I learned the  
concerns of individual Congressmen and their staffs. As a Congressional  
liaison officer in a large department and at the White House, I became  
aware of the workings of the Executive Branch and the role of liaison with  
the Congress in policy development and implementation. As Minority  
Counsel of the Ways and Means Committee, I was intimately involved in the  
writing of many of the laws under the jurisdiction of the Treasury  
Department and managed a staff similar in size to the one which works for  
the Deputy Under Secretary of the Treasury.

My years as a corporate executive of a major U. S. Corporation with  
responsibility for Washington operations have provided me with a basic  
understanding and knowledge of the concerns and workings of the private  
sector. Ultimately, many of these must be dealt with in the Treasury  
Department.

Finally, I have been and continue to be vitally interested in economic  
policy issues which are at the core of the Treasury Department's business,  
and believe I am substantively experienced in them to a degree that  
qualifies me for this position.

The CHAIRMAN. The subject of the hearing this morning is the nomination of Mr. John Meagher to be the Deputy Under Secretary of Legislative Affairs.

Mr. Meagher, I would like to welcome you before the Committee. I would say that Mr. Meagher is no stranger to many of us on the Committee. We have dealt with him in his many other roles here on the Hill in the past, most recently representing the LTV Corporation, which is a major corporation in my own State. I think Mr. Meagher is very well qualified for this new post. He has had more than 15 years of Government experience, most of that in the House of Representatives. We are glad to see you promoted, being over here at the present time.

He served for five years as legislative assistant to Congressman Pirnie. He later served for about 10 years as Minority Counsel and Staff Director of the Ways and Means Committee.

Mr. Meagher, I congratulate you on your appointment. And I would defer to my colleague, the ranking member, for any comment he might have.

Senator PACKWOOD. Mr. Chairman, I am delighted to have him because he is one of the few people that comes here that has actually been on the Hill longer than I have and it makes me feel young. [Laughter.]

The CHAIRMAN. I don't believe I will speak to that. [Laughter]

Senator PACKWOOD. You make me feel very, very young, Mr. Chairman. [Laughter.]

The CHAIRMAN. When I start talking about my first service up here, my kids say, Dad, that's back when the Earth's crust was just cooling, wasn't it?

Mr. Meagher, I am sure you have a statement you would like to make that I would like to hear.

#### STATEMENT OF MR. JOHN K. MEAGHER TO BE DEPUTY UNDER SECRETARY OF THE TREASURY (LEGISLATIVE AFFAIRS)

Mr. Chairman, Members of the Committee; I am delighted to be here today to have you consider my nomination to be Deputy Under Secretary of the Treasury Department.

I want to express my gratitude to you, Mr. Chairman, for expediting this hearing at a very busy time and wish to thank both staffs, particularly Mr. Wilkins, for their cooperation and effort.

This is a proud moment for me. The idea of returning to government service in this position is at once flattering and exciting. To have been chosen by President Reagan and Secretary Baker for this assignment is a great honor which I will always value. Confirmation by the Senate will be equally satisfying.

I come here not as a stranger but as someone who grew up in the legislative branch, and during the 13 years I spent on the Hill, I learned that two things above all are critical: honesty and fairness. I come to you pledged to always honor those two notions and am anxious to answer any questions you may have.

The CHAIRMAN. Mr. Meagher, you have a reputation for integrity and ability. It seems to me one of the problems you will be facing is your former association with LTV. They are a substantial corpora-

tion with some major problems. And they have some problems concerning pension policy, taxes, and trade policy.

How do you anticipate handling that kind of a situation in your role?

Mr. MEAGHER. Well, before I was nominated, or I guess right after I was nominated, I signed a statement that has been made available to the Committee and the staff. It states that I will not work on any matter that directly or indirectly will affect the LTV Corporation. I suppose that the question is, what is indirectly? I think that we have reached an understanding about—at least I have with the Staff—as to what those areas would be. I don't think that, for example, I could get involved in anything related to pension policy having to do with the LTV Corporation, or even with the steel industry, in particular, because that would necessarily involve the LTV Corporation.

Senator PACKWOOD. Mr. Chairman, I cannot think of a luckier excuse to be able to get out from under a problem. [Laughter.]

Mr. MEAGHER. You said it, Senator Packwood. I didn't.

But in fairness, that is what the law is as well as the practice. I raised this subject myself with the Staff in our interviews because I felt it was an important thing to have clarified. I don't want any question about that—I will not work on anything that is involved with the LTV Corporation, not only as a matter of law but as a matter of practice, because I think that that is the only fair way I can do my job and to satisfy those concerns that not only you raised but could be raised by others.

The CHAIRMAN. Do you have any arrangements to go back to LTV?

Mr. MEAGHER. Absolutely not. I will have no connection with the LTV Corporation. I will sever all connections once I have an opportunity to take this position.

The CHAIRMAN. How does your wife, Geri, feel about this?

[Mrs. Meagher displays a thumbs up.]

The CHAIRMAN. That is important. I have no further questions.

Senator PACKWOOD. Have you given any advice, or if you were to give the President advice, what would you suggest that he do about signing your veto in the debt ceiling with Gramm-Rudman-Hollings appended to it?

Mr. MEAGHER. I thought somebody might ask me that, Senator. And I read the paper this morning, and I see a picture of my prospective boss, with the caption "Urges President to sign bill."

It seems to me—and I don't know a great deal about this—but it seems to me that this is a method by which Congress and the President can get together or try to get together on dealing with the budget question. It is a chance.

Senator PACKWOOD. Only if he signs it.

Mr. MEAGHER. If he signs it.

I guess I have been in this business long enough to believe that you need to have a chance to do things. I cannot second-guess whether or not there will be sequestration of X number of dollars in the Defense budget or an increase in whatever people are calling, raising taxes today, revenue enhancement, or fine tuning, or whatever.
