Committee on Finance Announces Hearing and Markup on Nominations for HEALTH AND HUMAN SERVICES AND TREASURY POSTS

Washington, DC.—Senator Lloyd Bentsen (D., Texas), Chairman, announced Friday that the Committee will hold a hearing and markup on the nominations of Malcolm M.B. Sterrett to be General Counsel and Mary T. Goodde to be Assistant Secretary for Legislation for the Department of Health and Human Services. The Committee will also consider the nominations of Charles H. Dallara to be Assistant Secretary of Policy Development, and Edith E. Holiday to be Assistant Secretary of Public Affairs and Public Liaison for the Department of Treasury.

The hearing, to be chaired by Senator Spark Matsunaga (D., Hawaii), will be held on Wednesday, October 12, 1988 at 1:30 p.m. in Room SD-215 of the Dirksen Senate Office Building.

Office Building.

Mr. Sterrett is currently a Commissioner of the Interstate Commerce Commission, and Ms. Goedde has been the Acting Assistant Secretary for Legislation of HHS since May 1988. Mr. Dallara is presently Senior Advisor for Policy and Ms. Holiday is a public affairs and public liaison counselor to the Secretary of the Treasury.

OPENING STATEMENT OF HON. SPARK M. MATSUNAGA. A U.S. SENATOR FROM THE STATE OF HAWAII

Senator Matsunaga. The committee will come to order.

I would like to welcome our distinguished guests to their confirmation hearing. We will try to get a quorum during the hearing in order to vote on these nominations today if at all possible. We are, as you know, competing with the tax conference. So if we cannot get a quorum now we will try to get one as soon as possible.
In the interest of time I would like to ask Mary Goedde and Mal-

colm Sterrett to the witness table.

The individuals before you today will be working closely with the committee for the balance of the present President's term of office. Mary Goedde brings 15 years of experience in the legislative process to the new position. Her's is a proven record of service on a wide range of issues, including budgetary matters, appropriations, and Federal research priorities. She is also sensitive to the unique plight of native Hawaiians.

Malcolm Sterrett is relatively new to the Department of Health and Human Services, having spent most of his public career with the Interstate Commerce Commission. However, his work with the Senate Committee on Commerce and his experience in dealing with a broad range of complex litigation will be an excellent preparation

for the position of General Counsel.

I would like at this time to call upon Congressman Gradison who has requested that he be given the honor of introducing a constituent.

STATEMENT OF HON. WILLIS D. GRADISON, JR., U.S. CONGRESSMAN FROM THE STATE OF OHIO

Congressman Gradison. Thank you very much, Mr. Chairman, and a special thank you to you and the committee for scheduling this hearing under the circumstances of the final weeks of this session.

I am pleased to introduce to you formally Mrs. Mary Goedde, a native of my district in Ohio, who is the president's nominee to serve as the Assistant Secretary of Legislation at the Department of Health and Human Services.

Mary brings a great deal of legislative and political experience to this position, as you have already indicated, Mr. Chairman. She served a total of five years in an executive level capacity with the Reagan Administration at Health and Human Services, including her most recent position as the principal Deputy Assistant Secre-

tary for Legislation.

She represented the Department on the Interagency Task Force on Immigration Reform and the Deregulation Task Force and received the Bronze Mediallion Award from our former colleague in the Congress, Secretary Richard Sweicker. She has worked as a legislative assistant on the Hill for over seven years for Senator Taft, of Ohio, and Senator Hayakawa, of California. Mary also served as a legislative consultant for the Assistant Secretary for Legislation in the Department of Education before coming to the Department of Health and Human Services for the Second time in 1986.

She has served successfully as the Acting Assistant Secretary for Legislation, the position for which you are now considering permanent status since May.

Mr. Chairman, it is a great pleasure to be here to make in as positive terms as I am capable a strong recommendation to you on

behalf of Mrs. Goedde. Thank you, Mr. Chairman.

Senator Matsunaga. Thank you, Congressman Gradison, for taking the time to be with us. And, of course, you will be pleased to know, Mrs. Goedde, that whenever a member of Congress makes a recommendation, it is pretty, pretty hard to refuse.

And now before we get to our first witness I would like to have the ranking Minority member of the committee, give him the

pleasure of introducing Mr. Sterrett. Senator Packwood.

OPENING STATEMENT OF HON. BOB PACKWOOD, A U.S. SENATOR FROM THE STATE OF OREGON

Senator Packwood. Mr. Chairman, thank you.

First, let me indicate to those in the audience what I have done in case they did not hear. If by chance, Mr. Chairman, we did not get a quorum here, at least I have asked on the Republican side that they not raise any objections to a request I would hope you would make that the committee could meet after a vote on the floor, just in the cloak room, and we can do it on a moment's notice. But I can assure you there will be no objections coming

from our side if that happened.

I have known Malcolm Sterrett just over 10 years. I went on the Commerce Committee in 1977, and he had already served his Minority Staff Counsel, and then he started serving as Minority Staff Director when I went on the committee, as a Junior member. He stayed with the committee for four years, and then left us, and went off to the United States Railway Association, and finally down to the Interstate Commerce Commission as a Commissioner, although he had served earlier, working as an attorney for the Interstate Commerce Commission from 1967 to 1972. So I have had nothing but a long and favorable experience with Mal, and I guess in as many areas as the committee can deal with, and numerous ones, when he was on the Interstate Commerce Commission. Thus, clearly, the Commerce Committee has a great interest in what that Commission does.

There could not be a finer appointment for this job. Of course. I am hoping we have a Republican victory and some of these people will be extended in their positions. But if not, why I wish them well in the last three months of the Administration.

Mr. Sterrett. Thank you, Senator. Senator Matsunaga. Thank you, Senator Packwood.

Now we would be delighted to hear from you, Ms. Goedde, any words of wisdom.

STATEMENT OF MARY T. GOEDDE, NOMINEE TO BE ASSISTANT SECRETARY FOR LEGISLATION, DEPARTMENT OF HEALTH AND HUMAN SERVICES

Ms. Goedde. Thank you, Senator.

Mr. Chairman and members of the committee, it is an honor for me to appear before you today. And before I make any remarks, I just want to thank you for taking time out of your busy schedules. With the closing days of Congress, I know how hectic it is. And I am deeply honored that you have taken the time today. And I also want to thank the staff on the committee who have been so helpful to us and who are a pleasure to work with.

I ask permission to submit a brief statement for the record. And if I could just say that it is an honor for me to have been nominated by the President for the position of Assistant Secretary for Legislation at the Department of Health and Human Services, and to be a part of the team serving under the President and Secretary Bowen. I am conscious of the challenge that this presents to one such as myself who is dedicated to fulfilling the high standards of a responsive public servant, and building upon the legacy of my distinguished predecessors, I pledge myself to meeting that challenge to the utmost of my ability, and assure you that all those who serve with me in the Office of Legislation are and will continue to be committed to that objective.

I thank the Chairman.

Senator Matsunaga. Thank you. Without objection, your statement will appear in the record in full.

Ms. Goedde. Thank you.

[The prepared statement of Ms. Goedde appears in the appendix.] Senator Matsunaga. And now we will be happy to hear from you, Mr. Sterrett.

STATEMENT OF MALCOLM M.B. STERRETT, NOMINEE TO BE GEN-ERAL COUNSEL, DEPARTMENT OF HEALTH AND HUMAN SERV-

Mr. Sterrett. I have no prepared statement, but I would just like to say that I too am honored to be here as the President's nominee to be General Counsel of the Department of Health and Human Services. I consider it to be an extremely challenging position. In the short time left in this Administration I hope to be able to make a worthwhile contribution to the very complex and serious issues faced by the Department.

Finally, I would like to also express my appreciation—and I am sure that of all the other nominees here today—to the committee for its willingness to process our nominations at this late and busy

hour of the Congress. Thank you.

Senator Matsunaga. Thank you. And I might add here that had it not been for your friendship with the ranking minority member we may not be having the hearing here at this time. [Laughter.]

Mr. Sterrett. He is very persuasive.

Senator Matsunaga. Well thank you both for coming. Our next panel of nominees will be Mr. Charles H. Dallara to be Assistant Secretary of Policy Development, Department of the Treasury, and Miss Edith E. Holiday, to be Assistant Secretary of Public Affairs and Public Liaison, Department of the Treasury.

Is there any member of Congress here who wishes to say any-

thing prior to calling upon the two witnesses?

Senator Pryor. Mr. Chairman?

Senator Matsunaga. Senator Pryor.

Senator Pror. Pardon me, Mr. Chairman. I did have a recent conservation with Senator Nunn and Senator Fowler telling them that Ede Holiday would be before the committee. They both express regret that they could not come. Senator Nunn I think is on the drug bill, or handling the drug bill on the floor at this time, and Senator Fowler had a commitment that he could not rearrange, so they both do apologize.

Senator Matsunaga. That is right. I must say that Senator Pryor was here, the other Senator who came after me to hold these

hearings. [Laughter.]

And Senator Warner was supposed to be here.

Senator Pryor. I think he is handling the other part of the drug bill. [Laughter.]

Senator Matsunaga. Yes. Senator Warner had asked to be given

the privilege of introducing Mr. Dallara.

Senator Pryor. May I say a word, Mr. Chairman, about one of the nominees?

Senator Matsunaga. Yes. Certainly. Go right ahead.

OPENING STATEMENT OF HON. DAVID PRYOR, A U.S. SENATOR FROM THE STATE OF ARKANSAS

Senator Prior. I don't have any prepared statement. But Ede Holiday is before the committee today to be the Assistant Secretary of Public Affairs and Public Liaison in the Department of the Treasury. My wife and I have known Ede and her husband. We had the highest pleasure—the great pleasure—of going to their

beautiful wedding some few years back.

Let me say, Mr. Chairman, that even though Ede is not only our very good friend, she is also a Republican through and through. Her husband is a Democract through and through. Let me add that. So we have an interesting situation here today. And we are just proud that Ede is before the committee. She worked for former Senator Nick Brady, our friend, Nick Brady, when he was a member of the Senate. And she has now been taken to the Department with Secretary of the Treasury Brady, and we are very proud that he has chosen her for this position. And we hope to expedite this nomination of this very fine person.

Ms. HOLIDAY. Thank you, Senator Pryor. Senator Pryor. Thank you, Mr. Chairman.

Senator Matsunaga. Evidently Secretary Brady wants his own team in the Department. And, of course, Mr. Dallara's job will be to make sure that the important issues get to the Secretary in a timely fashion. He also will coordinate policy as directed by the Secretary. In other words, he will be Mr. Brady's right hand for special projects.

Mr. Dallara has several advanced academic degrees from the Fletcher School of Law and Diplomacy. In addition, he has held a number of important posts within the Treasury Department in the field of International Economics, which I think we can all agree, is one of the most important areas of interest to the Department

today.

He has spoken frequently and publicly on international economic questions, especially on the problems of debtor nations of which I

regret to say the United States is one.

Senator Warner was supposed to have been here to introduce Mr. Dallara. Miss Holiday also will be a close advisor to Secretary Brady. She will serve as Public Affairs and Public Liaison assistant. She has previously practiced law here in Washington, and has recently participated in the Bush-Quayle campaign. She was Secretary Brady's Legislative Director when he was a Senator representing the State of New Jersey.

Thank you all for being here with us today. The members of the committee look forward to hearing from you now unless Senator Warner gets here in time to say a few words before you say a few

words.

Senator Packwood. I think the faster we can move the better, Mr. Chairman. I am not sure I would wait for our fellow Senator to

Senator Matsunaga. All right.

Then we would be happy to hear from you first, Mr. Dallara.

STATEMENT OF CHARLES H. DALLARA, NOMINEE TO BE ASSIST-ANT SECRETARY OF POLICY DEVELOPMENT, DEPARTMENT OF THE TREASURY

Mr. Dallara. Thank you, Mr. Chairman. I will keep my statement very brief in light of the busy schedule you and your col-

leagues have today.

I would simply like to say that I am honored, as the previous nominees have indicated, to have been nominated by the President for a position in this Administration. I am also honored and greatly appreciative of your willingness, Mr. Chairman, as well as that of the ranking member, to schedule these hearings during such a busy time for the Senate. I probably should also express my appreciation to the other nominees who have close friends on the committee who helped make this hearing possible today. But I also would like to extend my appreciation to the many staff, those of the Finance Committee, the White House, and last but not least, the Treasury staff who have assisted in this process, and in particular, Assistant Secretary, John Meagher, and Deputy Assistant Secretary, John Harman.

I look forward very much, if I am confirmed, Mr. Chairman, to serving the Administration and the country in this new position and to working with Congress on the many issues before us. I am prepared to respond today to any questions you or your colleagues

may have. Thank you, Mr. Chairman. Senator Matsunaga. Thank you.

Do you have any questions of Mr. Dallara, Senator Pryor? Senator Pryor. I have no questions, Mr. Chairman.

Senator Matsunaga. No questions. I guess we will just have to go ahead and listen to what words of wisdom you have. [Laughter.]
Your actions, as revealed here by Senator Pryor, is one beyond

question because you married a Democrat. [Laughter.]

We would be happy to hear from you, Miss Holiday.

STATEMENT OF EDITH E. HOLIDAY, NOMINEE TO BE ASSISTANT SECRETARY OF PUBLIC AFFAIRS AND PUBLIC LIAISON, DE-PARTMENT OF THE TREASURY

Ms. Holiday. Thank you, Mr. Chairman.

I do not have a prepared statement, but let me too express the honor that I share with these nominees of being nominated for this position, and particularly my appreciation to you and the ranking member and other members of the committee, and in particular, the staff of this committee, for scheduling this hearing under incredibly short-time deadlines and with your busy schedules.

I look forward, if confirmed, to serving the President and serving this committee in any way I can. I appreciate your time today.

Thank you.

Senator Matsunaga. Well, thank you very much.

Senator Pryor. She sounds a lot better than Senator Warner I think. [Laughter.]

I am sorry he could not be with us today because I knew he wanted

to.

Senator Matsunaga. We will go into recess subject to the call of the chair. You will be notified as soon as we have had a quorum in one of these off-committee room meetings, possibly in the Capitol Building. But I am sure you will be notified by your own Senator as soon as this committee has taken action. It appears from what reports I have—oh, here comes Senator Warner. [Laughter.]

STATEMENT OF HON. JOHN W. WARNER, A U.S. SENATOR FROM THE STATE OF VIRGINIA

Senator WARNER. Mr. Chairman, what someone far more wiser than I observed one time that the hallmark of royalty punctuality, and you, Senators, ain't royal. But I would only plead guilty. We just finished a piece of legislation on the floor, base closing, as you know.

Senator Matsunaga. I see. Well we would be happy to hear from

you.

Senator WARNER. I think the best that I can do to show a courtesy to this distinguished nominee and to the members of the committee is to submit my statement for the record. It is very complete, very detailed.

Senator Matsunaga. Without objection, the statement will

appear in the record as though presented in full.

Senator Warner. I would simply add that I took a few minutes to call the Secretary of the Treasury, a former colleague and a member of the United States Senate, Mr. Brady. He said that he has observed this nominee's work for some period now, that each time he gives him an assignment it is performed very well, on time, and he always comes back and ask to do more. So having said that, we are fortunate, those of us and citizens too of this country, to have him serve subject to the confirmation by the Senate which I hope will be forthcoming.

I thank the chair and the distinguished ranking members for

their patience.

Senator Matsunaga. Well thank you very much for taking time from your busy, busy day to pay a respect to your constituent. Senator Warner. Thank you, Mr. Chairman. Senator Matsunaga. Just as I was about to pound my gavel, the committee stands in recess subject to the call of the chair. [Whereupon, at 1:55 p.m., the hearing was concluded.]

Mr. Chairman, it is a great pleasure to be here today to introduce to your Committee Dr. Charles Dallara, President Reagan's nominee to be Assistant Secretary of Treasury for Policy Development.

First, let me welcome to the Senate Dr. Dallara's wife CAROLYN and his two children, STRPHEN and EMILY.

Charles Dallara comes to this position with an impressive array of experience and background. Dr. Dallara served our country in the United States Navy in the early 1970s as an Admiral's aide and a Flag Lieutenant to a Rear Admiral, serving as Executive Assistant with a variety of duties, including Flotilla watch officer at sea. This coincided with my tenure as Secretary of the Navy so I can personally attest to how hard we worked the Flag Lieutenants and Admiral Aides.

Dr. Dallara received his Masters of Arts in International Economics, Masters of Arts in Law and Diplomacy, and his Doctorate of Philosophy from the Fletcher School of Law and Diplomacy of Tufts University.

After receiving his Masters degrees in 1975 and 1976, Dr. Dallara came to Washington to work in the Treasury's Office of International Monetary Affairs as an International Economist.

Mr. Chairman, that important position was just the beginning of Dr. Dallara's Washington career. He has been working in the Treasury, specializing in international monetary matters for the last twelve years, through some of the most challenging times for U.S. monetary policy this country has ever seen.

Appointed to the post of Special Assistant to the Under Secretary of Monetary Affairs at Treasury, he assisted the Under Secretary in the planning, coordination and implementation of Treasury policy on international monetary, trade and energy issues. Later, he rose to be the Special Assistant to the Assistant Secretary of Treasury for International Affairs. There he worked with the Assistant Secretary to formulate and implement U.S. international economic policies, including trade, monetary, investment and development policies.

Continuing his ascension at the Treasury Department, Charles went on to become Deputy Assistant Secretary of International Monetary Affairs, Senior Deputy Assistant Secretary for International Economic Policy and -- his current post -- Senior

Advisor to the Secretary. In all these positions he has had hands-on exposure to virtually all aspects of our Nation's international monetary policy.

In addition, Charles has represented the United States at the International Monetary Fund (IMF), first as Alternate Executive Director and currently as U.S. Executive Director. His responsibilities there have included presenting the U.S. position to the IMF's Executive Board on issues concerning IMF operation and policies, the international monetary system and economic stabilization programs.

Mr. Chairman, there is no question that the next several months will be critical in charting the course of international monetary policy into the next decade. Secretary Brady, just five weeks on the job, needs experienced people in key positions to help him through the important months ahead. Charles Dallara is an outstanding example of just such a person, and I hope the Committee will do all it can to speed his confirmation through the Senate.

Statement for Senator Sam Nunn Nomination of Edith E. Holiday October 12, 1988 Senate Finance Committee

I am particularly pleased to present Ede Holiday to the Committee. Ede is a citizen of Georgia, and I am proud that President Reagan has nominated her as Assistant Secretary of the Treasury for Public Affairs and Public Liason. She and her husband, Terry B. Adamson, a lawyer in Atlanta, are personal friends of Colleen's and mine. I also know her father, Harry Holiday, retired Chairman of Armco.

Perhaps more importantly, I also know that Ms. Holiday enjoys and has earned the confidence of the Secretary of the Treasury, Nicholas Brady. When Nick Brady was Senator Brady, where he earned the respect of all of us, Ms. Holiday served as his legislative director. When he was confirmed by this body several weeks ago to be Secretary, one of his first acts was to recommend. Ms. Holiday to the President for this important position of responsibility, trust, and confidence. Moreover, Secretary Brady was able to persuade Vice President Bush to release her from his current active political endeavors, where she has long served as Chief Counsel and National Financial and Operations Director for the Bush-Quayle '88 Presidential Campaign. She will now serve her country in this very essential and sensitive position in the Department of Treasury.

Ms. Holiday previously served as Special Counsel for the Fund for America's Future, and served as Executive Director for the Commission on Executive, Legislative, and Judiciary Salaries, 1984-1985, when Secretary Brady was serving as its chairman.
