Claudia,

It's on your chair. I have not gone through the grants to which drugs are involved with the grant. As you can see, he has very few pharma sponsored studies. Jeff and I will have to look through each grant to see which drugs are involved in the study and determine whether there is a potential conflict. He does seem to try to keep his consulting fees to less than \$10k for companies that are producing drugs that he studies. In looking at the IRB protocols, he did not disclose that he had a relationship with the makers of the drugs; however, the question on the IRB forms asked whether anyone has a relationship with the sponsor, the technology, or if the drug/technology was developed at Emory – he answered the questions correctly. The questions are being corrected on the eIRB system.

For the publications, again we would have read each one (and understand it) to see whether any drug/therapy is related to his consulting clients. In the 2004 management plan letter, we requested: "The Committee indicated that you must disclose your relationships with a company when you discuss the company's products, whether in publications or presentations. This requirement goes beyond the presentation of research results; it applies to all your communications."
