1	Senator Moynihan. A quorum is present. I
2	will ask for a voice vote.
3	Some members who necessarily cannot be here
4	will not be counted as absent. I would, however,
5	like to note that Senators Bradley, Mitchell, and
6	Breaux have asked that their proxies be voted on
7	behalf of our nominees.
8	I move that the committee recommend that the
9	nomination of Donna Shalala to be Secretary of
10	Health and Human Services be confirmed when
11	received by the Senate. Is there a second?
12	Senator Packwood. I second, Mr. Chairman.
13	Senator Moynihan. There has been a second by
14	the ranking Republican member, Senator Packwood.
15	Those all in favor will say aye.
16	[Chorus of ayes.]
17	Senator Moynihan. Those opposed?
18	[No response.]
19	Senator Moynihan. The recommendation will be
20	made unanimously.
21	Now, I move that the committee recommend that
22	the nomination of Roger Altman to be Deputy
23	Secretary of the Treasury be confirmed when
24	received by the Senate. Is there a second?
25	

1	Senator Packwood. I second, Mr. Chairman.
2	Senator Moynihan. There is a second from the
3	ranking Republican minority member, the Senator
4	from Oregon.
5	Those in favor say aye.
6	[Chorus of ayes.]
7	Senator Moynihan. Those opposed?
8	[No response.]
9	Senator Moynihan. The nomination will be
10	recommended unanimously.
11	Thank you very much. I know it has not been
12	easy to assemble this quorum. And it is fitting
13	that the quorum was finally made up with the
14	former Governor of Arkansas.
15	[Laughter]
16	Senator Boren. Let me say, Mr. Chairman, and
17	not to try to make the point again because I agree
18	with what Senator Chafee has said in terms of our
19	being thorough and all members having a chance to
20	ask questions, but I understood from his comments
21	a moment ago that once we have completed our
22	deliberations and all have had a chance to ask
23	questions, that he would not object, I believe, to
24	allowing you to consider that the quorum that was
25	constituted earlier would be a quorum and to allow

1	all members of the committee then to have a chance
2	to vote.
3	We do have these problems. We have had the
4	agenda put before us. We have heard it in many
5	different ways. And I think none of us would want
6	this nominee to lose a single day, let alone a
7	week or two in terms of being able to get on top
8	of these issues.
9	So I would simply like to move, Mr. Chairman,
10	that you be authorized to consider that the quorum
11	made earlier be considered a quorum after having
12	completed the questioning and deliberations, that
13	you be allowed to poll all members of the
14	committee for purposes of reporting out this
15	nomination.
16	Senator Moynihan. I thank the distinguished
17	Senator.
18	Is there a second?
19	Senator Baucus. I second, Mr. Chairman.
20	Senator Moynihan. Is there objection?
21	[No response.]
22	Senator Moynihan. Without objection, so
23	ordered.
24	I move that under previous agreement that the
25	committee recommend that the nomination of Michael

1	Kantor to be the United States Trade
2	Representative be confirmed when received by the
3	Senate.
4	Senator Baucus. I second, Mr. Chairman.
5	Senator Moynihan. A second is heard.
6	Those in favor will say aye.
7	[Chorus of ayes.]
8	Senator Moynihan. Those opposed?
9	[No response.]
10	Senator Moynihan. There are none opposed.
11	The chair has written proxies or verbal proxies
12	from all the other members of the committee. And
13	accordingly, the recommendation will be unanimous
14	by the Committee on Finance.
15	[Applause]
16	Senator Moynihan. I would like Ambassador-
17	to-be Kantor to know that two young nieces or
18	nephews did their very best in the front row, but
19	they just fell sound asleep.
20	[Laughter]
21	Senator Moynihan. They are not here for this
22	moment.
23	Mr. Kantor. With my presentation, Mr.
24	Chairman, I do not blame them.
25	[Laughter]
