FINANCE COMMITTEE TO CONSIDER NOMINATION FOR U.S. TREASURER

WASHINGTON, DC—Senator Daniel Patrick Moynihan (D-NY), Chairman of the Senate Committee on Finance, announced today that the Committee will meet to hear testimony from and consider the nomination of Mary Ellen Withrow to be Treasurer of the United States.

The nomination will be considered *immediately following an already scheduled hearing set to begin at 10:00 A.M. on Wednesday, February 9, 1994* in room SD-215 of the Dirksen Senate Office Building.

OPENING STATEMENT OF HON. DANIEL PATRICK MOYNIHAN, A U.S. SENATOR FROM NEW YORK, CHAIRMAN, COMMITTEE ON FINANCE

The CHAIRMAN. Could I point out that we have on our agenda an executive session to consider the nomination of Mary Ellen Withrow of Ohio to be Treasurer of the United States. We note that we have a quorum present. If the quorum is agreeable, Senator Packwood and I will conduct that hearing immediately after Dr. Reischauer has left.

When that happens, Lloyd Bentsen can finally sign the dollar bill, which he has wanted to do all these years.

Senator DOLE. Do you want to vote it out now?

The CHAIRMAN. Could I ask for a vote? Those in favor, say aye. [A chorus of ayes.]

The CHAIRMAN. Those opposed?

[No response.]

The CHAIRMAN. The ayes have it.

Our distinguished colleagues Senator Glenn and Senator Metzenbaum are in the Chamber.

The Committee will now go into executive session for the purpose of hearing the testimony from Mary Ellen Withrow, who has been

nominated by the President to be Treasurer of the United States. She is accompanied by two of our most eminent Senators and she has a statement for us.

I do not know how quite to put this to you, Mrs. Withrow, and much less to Senators Glenn and Mr. Metzenbaum, but you have already been approved. [Laughter.]

Ms. WITHROW. That is wonderful.

The CHAIRMAN. Senator Glenn, we welcome you, sir.

STATEMENT OF HON. JOHN GLENN, A U.S. SENATOR FROM OHIO

Senator GLENN. Thank you, Mr. Chairman. I will be very brief. I do not want to detract from that introduction.

It is a real opportunity and a pleasure to introduce an individual who is a close personal friend, well known to me and all Ohioans. We have worked closely together through the years. I am pleased that she is going to be our next U.S. Treasurer.

She has set a new standard for public service in Ohio. There was a lot of resistance, as a matter of fact, to her being nominated for this post because the people of Ohio did not want to lose her.

I could go on with all of her accomplishments, but I am sure you have those in her biography. I will note just a couple of them. Since being elected Ohio State's Treasurer in 1983, she has earned the State a record, \$2 billion in investment income, which shows she has some investment acumen and she has implemented a new link deposit initiative which is providing affordable capital to Ohio small business and farmers through these innovative programs.

Mary Ellen has not only been the guardian of Ohio tax dollars, which has resulted in jobs, but also has been a guardian of Ohio schools by creating an asset reserve account, which is providing schools and local governments safe higher yield returns on their short-term investments.

Mr. Chairman, you indicated she has already been approved. I cannot think of a better choice for this job. She looks forward to it. She is certainly highly qualified for this job and we look forward to getting on with the work ahead.

There has been a long delay with all the difficulties of the appointment process with which we are all familiar. But I am very proud to be here and recommend her to you.

As you indicated, she has already been approved. You cannot beat that.

The CHAIRMAN. You are very generous sir. It was in the context of the fact that you would be here to endorse her.

Senator Metzenbaum?

STATEMENT OF HON. HOWARD METZENBAUM, A U.S. SENATOR FROM OHIO

Senator METZENBAUM. Mr. Chairman, over 50 years ago I became a State Legislator and at that time I learned something. That is, if you have the votes speak softly and speak shortly. If you do not have the votes, make a long, wonderful argument as to why somebody should be confirmed or whatever.

In this case, you have indicated we have the votes. Mary Ellen Withrow has been one hell of a good Treasurer for the State of

Ohio. She will make an excellent Treasurer for the United States. I rest my case.

The CHAIRMAN. Thank you, sir.

Mrs. Withrow, you have a statement which we will place in the record. But you proceed exactly as you like.

The CHAIRMAN. Thank you, Senators.

STATEMENT OF MARY ELLEN WITHROW, NOMINEE TO BE THE TREASURER OF THE UNITED STATES

Ms. WITHROW. Mr. Chairman and members of the committee, Ohio has been blessed with two great Senators. It has been such a pleasure to have them represent me in Ohio and in the Nation.

I want to say that it is an honor to appear before your committee and to thank President Clinton and Secretary Bentsen for the opportunity to serve. I have experienced 25 years in public office and have enjoyed every minute of it. I look forward to this experience as U.S. Treasurer.

It is going to be great to serve the people of the Nation and to have the experience of sharing the signing of the money with Secretary Bentsen. Thank you very much.

The CHAIRMAN. And you are going to solve the pressure of what to do about the dollar bill, are you not?

Mrs. WITHROW. We certainly are going to look at it.

The CHAIRMAN. You are going to look at it.

Mrs. WITHROW. Yes.

The CHAIRMAN. Senator Packwood?

Senator PACKWOOD. We have not had a chance yet to meet Ms. Withrow. But I read your resume.

Mrs. WITHROW. That is right.

Senator PACKWOOD. And if you are not qualified for this position, there is nobody that is qualified for it.

Mrs. WITHROW. Thank you.

Senator PACKWOOD. Good luck.

Mrs. WITHROW. Thank you very much. I guess I am the first County Treasurer, State Treasurer to ever become U.S. Treasurer.

The CHAIRMAN. It just shows that every so often merit is recognized.

Mrs. WITHROW. Thank you.

The CHAIRMAN. We thank you very much and we congratulate you and the committee will report your nomination to the floor for executive session. Get your pen ready. I do not know of the time. We will try to do it today or tomorrow. If we do not, it will be 10 days because we are in recess next week. But the committee has done its part.

Mrs. WITHROW. Thank you.

The CHAIRMAN. Thank you, Senator Packwood.

Senator PACKWOOD. Thank you.

[Whereupon, at 12:48 p.m., the hearing was adjourned.]

PREPARED STATEMENT OF MARY ELLEN WITTHROW

Mr. Chairman and Members of the Committee: It is an honor for me to appear before you today as the nominee for Treasurer of the United States. I want to take this opportunity to publicly thank President Clinton and Treasury Secretary Bentsen for this opportunity to serve.

And it is a privilege for me to be introduced to this body by two distinguished gentlemen.

Ohio is blessed to have two great Senators who have worked so diligently for the citizens of our state and our country. I would like to thank John Glenn and Howard Metzenbaum for their kind words of introduction. I am so very proud to be represented in the Senate by these two leaders . . . for they are truly legends.

In my 25 years of public service, I have been fortunate to work with officials at the local, county, state and national levels. I believe cooperation between the many levels of government is imperative and I have been a longstanding advocate for such cooperation. Through my leadership positions in national professional organizations I have had the opportunity to share ideas and programs with colleagues, other financial experts, and industry leaders from throughout our Nation. Coupled with my sincere dedication, I believe these experiences qualify me for the task ahead.

In this country and around the world, the security of our monetary system is paramount. Nothing is more important to this end than the confidence people have in our money. As U.S. Treasurer I want to help guarantee that confidence is always there, that we keep our money secure and that we take the proper steps to eliminate counterfeiting.

These programs helped Ohio's small businesses create jobs, assisted the state's agricultural community with low interest financing, and helped local governments and school districts more easily invest their funds and get a better return for their money.

All these programs were added while keeping the treasury staffed at roughly the same size as when I took office.

In this position and as Treasurer of Marion County, Ohio, where I worked closely with taxpayers on a daily basis, we eliminated waste and made our services more convenient to the public. I plan to continue that philosophy if confirmed as U.S. Treasurer, and I am eager to assist President Clinton and Secretary Bentsen in their efforts to cut waste and to reinvent government.

As a native Ohioan, a wife and mother of four daughters, who now have families of their own, I look forward to this unique opportunity and high honor to serve our country and our people as U.S. Treasurer.


