# NOMINATION OF MICHELLE A. SMITH, TO BE ASSISTANT SECRETARY OF THE TREASURY FOR PUBLIC AFFAIRS

### WEDNESDAY, MARCH 29, 2000

## OPENING STATEMENT OF HON. JAMES M. JEFFORDS, A U.S. SENATOR FROM VERMONT

Senator JEFFORDS. All right. Let us now turn to consideration of the nomination of Michelle Smith. Thank you for waiting this

morning, Ms. Smith.

You have been nominated to the position of Assistant Secretary of the Treasury for Public Affairs. Your office is responsible for developing and implementing press strategy for the Treasury Department. In short, your role is to put the public face on the actions of the Treasury Department.

As we all know from our own experience, this is an important, and sometimes difficult, position to be in, and I look forward to

hearing from you today.

I am now happy to turn to my good friend, Senator Moynihan, for his comments.

### OPENING STATEMENT OF HON. DANIEL PATRICK MOYNIHAN, A U.S. SENATOR FROM NEW YORK

Senator MOYNIHAN. Well, thank you, Mr. Chairman.

On February 23, the President nominated Ms. Smith to be Assistant Secretary for Public Affairs. Since that date, this committee has had a very busy schedule, and we have only just now gotten to you.

But I know that Secretary Summers is most particularly interested in this matter, and that we are not only pleased to have you, but we are pleased to have someone who has a career of the kind

you only knew in the nineteenth century.

This young lady is about to become a member of the sub-cabinet and began her life in the mail room, slaving away for Lloyd Bentsen of Texas. Here she is, arisen to this eminent position, and we welcome you.

Senator JEFFORDS. I see you have some members of your family with you. Would you please introduce them?

Ms. SMITH. Thank you very much. This is my husband, Blake

and my daughter, Madeleine.

Senator MOYNIHAN. Welcome, sir.

Senator JEFFORDS. Welcome.

Please rise.

[Whereupon, Ms. Smith was duly sworn.]

Senator JEFFORDS. Thank you.

Would you please proceed with your statement?

## STATEMENT OF MICHELLE A. SMITH, NOMINATED TO BE ASSISTANT SECRETARY OF THE TREASURY FOR PUBLIC AFFAIRS, WASHINGTON, DC

Ms. SMITH. Thank you, Senator Jeffords and Senator Moynihan, for the opportunity to appear before you today. I consider it a great honor and a privilege to have been recommended by Secretary Summers and nominated by President Clinton for the position of Assistant Secretary for Public Affairs at the Treasury Department.

As Senator Moynihan said, I was fortunate to begin my career working for the former chairman of this distinguished committee, Senator Lloyd Bentsen. I was working in his mail room. In 1992, I became his deputy press secretary and was able to work with his long-time advisor and press secretary, Jack DeVore. Their example continues to inspire me to the highest ideals of public service.

For the past 7 years it has been my privilege to serve in Treasury's Office of Public Affairs under three exceptional leaders: Secretary Bentsen, Secretary Rubin, and Secretary Summers. They

have taught me a great deal.

Above all, they have demonstrated the importance of an unfailing commitment to earning the public trust through truthfulness and honest dealings. By their actions, they have shown me that this is not only a vital ingredient of our dealings at home, but in our international relations as well.

If confirmed, I will continue to dedicate myself and my office to maintaining the high standards of excellence they have set for responsiveness and openness with the American public, their rep-

resentatives in Congress, and with the press.

In closing, Mr. Chairman, I would like to express my deep gratitude to Secretary Summers. For 7 years, I have depended on his sound professional and personal guidance and I have been encouraged and inspired by his courage to do what is right.

Thank you again for the opportunity to be here. I would be pleased to answer any questions you or Senator Moynihan might

have.

Senator JEFFORDS. Well, thank you very much. A very inter-

esting life. Welcome.

I have some questions I have to ask under the rules. First, is there anything you are aware of in your background that might present a conflict of interest with the duties of the office to which you have been nominated?

Ms. SMITH. No, there is not.

Senator JEFFORDS. Second, do you know of any reason, personal otherwise, that would in any way prevent you from fully and

honorably discharging the responsibilities of the office to which you have been nominated:

Ms. SMITH. No, I do not.

Senator JEFFORDS. Third, do you agree without reservation to respond to any reasonable summons to appear and testify before any duly constituted committee of Congress, if you are confirmed?

Ms. Smith. Yes.

Senator JEFFORDS. Ms. Smith, you have served for the past year and a half as Deputy Assistant Secretary for Public Affairs. You have also been at Treasury since 1993. Could you tell us what you have learned from this experience, and if there are any changes that you intend to make in the office?

Ms. SMITH. Thank you. I appreciate the opportunity. I believe my predecessors at Treasury, namely Jack DeVore and Howard Schloss, have set our office on the right path. As I mentioned in my statement, I will continue to dedicate myself to that high stand-

ard of excellence.

I believe it is important and key to democracy that the American public and the press have an opportunity to know what their elected and appointed officials are doing, and I will continue to make that my goal, to deal honestly, openly, and professionally with them.

Senator JEFFORDS. Senator Moynihan, any questions?

Senator MOYNIHAN. I have one question, sir, and it is a brief one. I believe you remarked in your opening statement that you are so pleased that Secretary Summers always did what was right. Did you say that?

Ms. Smith. Yes, sir, I did. Senator Moynihan. How do you know what is right in the world of international markets? Do you mean, he has always done what he hopes is right?

Ms. SMITH. Right. I have been inspired by his commitment to do

what is right. I believe he-

Senator MOYNIHAN. Do you really think there is such a thing in economics as that which is right?

Ms. SMITH. In life, yes, sir, I do. Senator MOYNIHAN. Think about that for a bit, would you, and ask the Secretary. Would you do that as a personal favor?

Ms. SMITH. Yes, sir. I would be happy to. Senator MOYNIHAN. I would appreciate it.

Thank you, Mr. Chairman. You will have no difficulty.

Senator JEFFORDS. Thank you very much. You have satisfied me. So I will pass that on to the chairman.

Senator MOYNIHAN. Right. Senator JEFFORDS. With that comment, the committee is now adjourned, right on schedule.
