I had to arrange boards and commissions in Reagan and in Bush 41, and we are a “sex, geography and political spectrum” balanced and interesting lot, we'd have cleared the White House!

Ladies Only:

Could you send me three points for our ladies-only night with Maria and the other women of the Right to Bear Arms? Don't panic about the reference to journalists, David got his buck yesterday and doe today in Missouri and he'll make sure any of us are prepared if and when we do press. With translations it is usually surface information and they are interested to know about a culture we know well. For example Kim you know media and how many people are affected by the information your husband can share freely in America, Hilary you can talk about hunting and how things have changed in a generation; that you don't have to stand by your man to be a world hunter. Julie, we have not met but just law enforcement and some of the brave men you know and how rigorous the training and yearly updates are, the practice the police all do – or we can each or all opt out of press. IWF is the think tank I am a part of, so gun policy but I never cover anything controversial, so for example, the difference between where I grew up in Texas where everyone knew guns and hunting verses gun controlled DC where only the criminals have guns. Or that when I grew up you took your BB gun out and shot whenever, and now it is licensed and seasoned and restricted and ... if they ask me a question I don't know or don't want to answer I talk about skeet shooting and picking the cheapest gun there as my favorite because it fit comfortably and I don't do that with shoes. We have more latitude than the men.

Sheriff David A. Clarke Jr. - Wisconsin

Elected to a fourth term with increasing margins each time, Milwaukee County Sheriff David A. Clarke Jr. is a law enforcement executive with 37 years of experience, 24 with the Milwaukee Police Department (MPD). For example in 4 years, the specialized Homicide Division team, arrested more than 80% of their 400 investigated homicides, well above the national average of 60%.

Rising through the ranks, Clarke retired as Commanding Officer of MPD's Intelligence Division, responsible for producing and sharing intelligence and providing dignitary protection in conjunction with the Secret Service, the Department of State, and other federal agencies. He served as liaison to all federal law enforcement agencies.

Sheriff Clarke holds a masters of arts in security studies from the U.S. Naval Postgraduate School, Center for Homeland Defense, where his thesis analyzed the need to balance domestic intelligence operations with protection of privacy and civil liberties. He holds a bachelor degree summa cum laude in Criminal Justice Management from Concordia University Wisconsin where he was 2003 Alumnus of the Year and is a graduate of the FBI National Academy and the FBI's Annual National Executive Institute.

Honored with numerous national and international awards and cover stories in *National Review* and *America's 1st Freedom*, Clarke is a frequent guest in U.S. television and print, including CBS Evening News, CNN, Lou Dobbs, Sean Hannity, Megyn Kelly, National Public Radio, and Bill O'Reilly.

He founded Air Ambulance, Inc., one of the original civilian medical transport companies, establishing service in California and Hawaii.

A big game hunter on six continents with 135 species listed in the Safari Club Record Book, Dr. Goldschlager has earned the World Hunting Zenith Award, and is a Life Member of Safari Club International (SCI), Ducks Unlimited, the Mule Deer Foundation and other species organizations. He has served on numerous boards including the Mzuri Wildlife Foundation (MWF), a San Francisco based organization founded to promote education, conservation and to protect wildlife habitats, and was awarded their Sportsman of the Year Award in 2013.

Dr. Goldschlager is a Benefactor Life Member of the NRA, a Charlton Heston Ambassador-level member of the NRA Ring of Freedom, and a member of the Hunter's Leadership Forum's President's Founders Club. His resume includes an extensive list of societies, honors, publications and clinical trials.

His second passion is sailing and boating on San Francisco Bay and in the Caribbean. He is a member of the St. Francis Yacht Club.

Hilary Goldschlager - California

Ms. Hilary Goldschlager is a USA Water Polo Coach and a USA Swimming Level II Coach at Palo Alto Stanford Aquatics (PASA) in California. PASA is ranked fifth in the nation for the quality of its program for producing Olympic swimmers year after year. She founded *Elite Aquatics Training Corporation* to provide private and academic counseling for college-bound student athletes.

Ms. Goldschlager practices emergency medicine as a paramedic, is trained in search and rescue, and attended the San Mateo County Sheriff's Academy.

She is an NRA Ring of Freedom, Benefactor and Life Member and the youngest member elected to the Executive Committee of the NRA Women's Leadership Forum. An avid shooter and hunter, she is involved in Safari Club International (SCI), SCI Sables, the Mzuri Club, and on the youth committee for Ducks Unlimited. An accomplished big game huntress, she has taken 38 species on several continents, including darting a rhino in South Africa that ranks number one in the SCI record book.

Joe Gregory – Tennessee

Mr. Joseph R. Gregory leads the dynamic professionals managing the diversified global investment portfolio at Gregory Management Company, LLC.

With his wife Cindy, he runs The Master's Table, a private, charitable children's ministry foundation, and serves on the Board of Directors for Kingsway Charities, a family foundation that has donated more than one billion dollars in medical supplies and pharmaceuticals to third world missions.

As founder of the Ring of Freedom, Mr. Gregory created a program that raised \$128 million for the NRA in its initial year. He was the inaugural recipient of the NRA Ronald Reagan Leadership Award, the highest award offered for civilian service.

Mr. Gregory co-founded King Pharmaceuticals and served as Vice-Chairman of the Board of Directors, Chairman of the Audit Committee, Corporate Secretary and President/CEO of the subsidiary, Monarch Pharmaceuticals. When he retired in 2003, King was a Fortune 500 public company with more than 2,200 employees, \$1.6 billion in sales and a market capitalization of \$10 billion. He and his family still manage Gregory Pharmaceuticals, manufacturing prescription and over-the counter medications.

Mr. Gregory has served on numerous University Boards of Trustees including Regent, King, Palm Beach Atlantic and Milligan University, where he holds an honorary Doctorate Degree in Business. He is a Foundation Fellow at Harris Manchester College of the University of Oxford.

The Gregorys have established the Joe and Cindy Gregory Aid Center in Har Tuv, Israel to support social needs of the poor and underwritten support for hundreds of American pastors on trips to Israel including an upcoming trip of 1,000 pastors in September 2016. Recently, Mr. Gregory re-established a pharmaceutical enterprise called Gregory Pharmaceuticals along with his family to manufacture prescription and over-the counter medications.

Joe and Cindy have two sons, Jonathan and Josh, and are members of Tri-Cities Baptist Church in Gray, Tennessee.

David A. Keene - Maryland

David A. Keene is the Opinion Editor of *The Washington Times*. While serving the traditional two one-year terms as President of the largest Second Amendment membership organization in the U.S., the NRA, Keene led the "All-In" Campaign against electing gun-control advocates in 2012, worked tirelessly to keep the U.S. from adopting further gun control legislation in 2013, and grew the organization from four to five million plus members. He remains on the Board and Executive Council.

From 1982 to 2011, Keene was the elected Chairman of the American Conservative Union (ACU), the nation's oldest and largest grassroots conservative lobbying organization and the major organizer of the annual CPAC, the Conservative Political Action Conference. Under Keene's leadership, CPAC grew from a small issues conference of a few hundred attendees to a national platform of more than 11,000 conservative activists attendees in Washington, DC and more than 250,000 attendees online. Attendees see and hear the leaders of the conservative movement and to network with fellow conservatives from around the country and the world.

While holding these volunteer roles, Keene was Of Counsel to the Carmen Group, a Washington governmental affairs firm, and on the boards of the Constitution Project, the Montana Policy Institute, and The Center for the National Interest and a founding member of Right on Crime, a conservative criminal justice reform organization. In addition to advising local, state and national figures, he has been Southern Regional Political Director for Ronald Reagan's 1976 presidential campaign; National Political Director for George Bush's 1980 presidential race; Senior Advisor to former Senator Bob Dole in 1988 and advisor to Dole's presidential campaign in 1996; and an advisor to Mitt Romney's first Presidential bid.

A Special Assistant to Vice President Spiro Agnew in the Nixon White House, Keene then served as Executive Assistant to New York Senator Jim Buckley in charge of the landmark first Supreme Court fight on campaign finance reform. He has been a John F. Kennedy Fellow at Harvard University's Institute of Politics, a First Amendment Fellow at Vanderbilt University's Freedom Forum, and a member of the Board of Visitors at Duke University's Public Policy School. He was the National Chairman of Young Americans for Freedom as a student and graduated from the University of Wisconsin Law School.

Keene is recognized as one of the chief spokesmen for conservative principles and politics on television, radio, and in print and is widely quoted. For decades, he wrote a regular column for *The Boston Globe* then *The Hill* and authored articles in *Human Events*, *National Review*, and *the American Spectator*.

Donna Wiesner Keene – Fort Washington, MD

Donna Wiesner Keene is CEO of BrainTrain, a business specializing in marketing and communicating political ideas and projects to policy-makers and citizens. In the 107th Congress, Mrs. Keene lobbied for fundamental tax reform for the Coalition for Fundamental Tax Reform, a coalition she helped grow to represent more than 8 million citizens.

In the second Bush Administration, she worked in disability policy at the U.S. Department of Education. In the first Bush Administration, as Director of the Executive Secretariat for the Education Department, she managed the largest staff in the Secretary's Office, represented the Secretary and Deputy Secretary on the Total Quality Management Task Force, and chaired the Information Technology Committee. She served as a Reagan Administration as Special Assistant for Intergovernmental Affairs in the Office of Secretary of Labor Bill Brock, where she focused on working women's issues.

Keene writes as a senior fellow at the Independent Women's Forum, holds a Masters in International Transactions from George Mason University and a Bachelor of Science in Hotel Administration from Cornell University with an emphasis on marketing and engineering.
