1	OPENING STATEMENT OF HON. RON WYDEN, A U.S. SENATOR FROM
2	OREGON, CHAIRMAN, COMMITTEE ON FINANCE
3	
4	The Chairman. The Finance Committee will come to
5	order. We meet today to consider three pending
6	nominations before the Finance Committee: Mr. Jeffrey
7	Arbeit, Ms. Cathy Fung, and Mr. Ben Guider.
8	We are going to use this time to make statements
9	on the nominees. I am going to make a statement
10	followed by Senator Crapo, then followed by any other
11	Finance member who wishes to make a statement.
12	At that point if we have a quorum, we will proceed
13	to the vote. It appears we are not going to have a
14	quorum, and we would recess then until the next roll
15	call vote on the Senate floor, when the committee would
16	reconvene off the floor to have the vote.
17	The majority and minority staff have discussed
18	this. I believe this is acceptable to you, Senator
19	Crapo?
20	Senator Crapo. Yes.
21	The Chairman. Okay.
22	The Finance Committee meets this morning to vote
23	on three nominations, Jeffrey Arbeit, Cathy Fung, and
24	Ben Guider, all nominated to serve as judges of the
25	United States Tax Court. I am going be very brief, then

- 1 turn it over to Senator Crapo.
- 2 The Tax Court is an essential feature of our tax
- 3 system, and it is the best opportunity Americans have to

- dispute a bill before they have to pay. And as I am
- 5 saying to all the nominees at this time, this can be a
- 6 very worrisome, if not frightening process for those
- 7 typical Americans trying to figure out how they are
- 8 going to get through it and deal with a dispute that
- 9 could possibly have them paying significant sums of
- money.
- So, this process has got to be as fair as possible
- for all of those concerned, taxpayers and all of the
- parties, and that way, we could make it in a position
- 14 to -- to avoid the pressure that would otherwise fall on
- 15 other courts, but also to make it more understandable
- and more bearable to those typical Americans going
- 17 through it.
- 18 So today, Jeffrey Arbeit will be first up, who
- 19 served for nearly a decade as a legislative counsel for
- 20 the staff of the Joint Committee on Taxation, whose work
- 21 is focused on some of the most complicated areas of tax
- law, including proposals dealing with international
- trade issues and financial markets.
- 24 He brings extensive private-sector experience and
- clerked on the Tax Court as well. We repeat, as we have

1	on a number of occasions, how much we appreciate the
2	terrific team at the JCT. The committee could not do
3	our jobs without their professionalism and expertise,
4	and we are sorry to lose anyone from JCT, but we know
5	Mr. Arbeit will make an excellent judge.
6	Next up will be Cathy Fung, the Deputy Area
7	Counsel at the IRS Office of Chief Counsel, where she
8	held multiple positions since 2009. Like Mr. Arbeit,
9	she brings valuable private-sector experience and
10	previously served as an attorney/advisor for a Tax Court
11	judge.
12	Finally, Ben Guider has experience spanning a
13	decade and a half advising clients on a variety of
14	issues including low-income housing and tax-exempt
15	bonds. He is currently an affordable housing attorney
16	and a member of the American Bar Association Forum on
17	Affordable Housing and Community Development Law.
18	The group of nominees had an excellent hearing a
19	few weeks ago. I support each of them, and I want it
20	understood that I have talked to the ranking minority
21	member, Senator Crapo. I have talked to Senator
22	Cassidy. I have talked to a number of colleagues, and I
23	believe we have strong bipartisan support for them.

25 was pleased the Senate voted yesterday to advance the

One final note on the Tax Court nominations. I

1	nominations of Adam Landy and Kashi Way to serve as Tax
2	Court judges. We are, as I indicated, working with our
3	colleagues to ensure we can bring Rose Jenkins's
4	nomination to the floor for a final confirmation vote as
5	soon as possible, so she can get to work for the
6	American people.
7	Senator Schumer has assured me that it is a
8	priority for him. Ms. Jenkins is another highly
9	qualified nominee, and I strongly support her
10	nomination. Hopefully we can move all these nominations
11	soon, and I just close by way of saying we all try to
12	look at the future of our work, and I am hoping for a
13	future that makes this a more understandable and
14	bearable experience in this unique Tax Court for
15	citizens, and I have appreciated that Senator Crapo has
16	taken an interest in this as well.

21	this is something that would be uniquely bipartisan on
22	our watch.
23	Senator Crapo. Thank you. And I will say that
24	with regard to these three nominees, each of these
25	nominees are qualified. They bring unique backgrounds

- 4 providing constructive advice in the formulation of key

- 5 legislation, and I particularly appreciate his work with

- 7 If confirmed, I expect that each of these nominees
- 8 will carry out their duties with the highest degree of
- 9 skill and integrity, and for these reasons I will be
- voting "yes" on each of the nominees. I encourage my
- 11 colleagues to do the same.
- 12 Thank you, Mr. Chairman.
- 13 The Chairman. Thank you, Senator Crapo.
- 14 All right. I think Senator Crapo and I can look
- around the dais and see there is not a quorum present.
