1	OPENING STATEMENT OF HON. RON WYDEN, A U.S. SENATOR FROM
2	OREGON, CHAIRMAN, COMMITTEE ON FINANCE
3	
4	The Chairman. The Finance Committee will come to
5	order. This morning the Committee takes up three
6	nominations, two for Deputy Trade Representative, one
7	for Assistant Secretary of Health and Human Services.
8	It is going to be a busy morning. We have got a lot of
9	committees conducting business. To assure that we have
10	a quorum, we will have a vote on the nominations as soon
11	as a quorum is present, and I will have a brief
12	introductory statement, and Senator Crapo will have a
13	brief introductory statement. Other members may have
14	introductory statements they want to give, as well.
15	So today we will vote on three nominations for
16	important roles within the Biden Administration. Dr.
17	Melanie Egorin, nominated to serve as the Assistant
18	Secretary for Legislation at the Department of Health
19	and Human Services. She is currently a top staff member
20	on the House Ways and Means Committee. Chairman Neal
21	joined the committee for last month's nomination
22	hearing, and he talked about Dr. Egorin's
23	professionalism, her diligence, and her ability to bring
24	people together. He also spoke about her deep
25	experience on health policy. If and when Dr. Egorin is

1 confirmed, we are going to keep her busy, from mental 2 health care to prescription drug costs, to home- and 3 community-based services. She will have many 4 assignments. 5 The Finance Committee is hard at work on improving 6 health care in America. It is going to take a lot of 7 close collaboration with the Department of Health and 8 Human Services' Secretary Becerra and his team, and Dr. 9 Egorin is going to have a big role to play in the months 10 ahead. 11 Next up are two nominees for the position of Deputy 12 U.S. Trade Representative under Ambassador Tai, Sarah 13 Bianchi and Jayme White. Ms. Bianchi is a long-time 14 member of the Biden economic team who has served in a 15 number of different policy roles -- the Office of 16 Management and Budget, the Domestic Policy Council, the

Management and Budget, the Domestic Policy Council, the Office of the Vice President, and she has also been a staff member.

Jayme White is a familiar face, of course, to all of us at the Finance Committee. He worked in our office in 2009 and has been the top trade and competitiveness advisor for Senate Finance Democrats since 2014. I know from experience that Jayme gets results. For example, he was the key staff member responsible for passing the Enforce Act in 2016, and it is now a key trade

1	enforcement	tool	that	cuts	through	abuses	to	protect
2	American wo	rkers	and 2	Americ	an jobs.			

As a result of Jayme and Ambassador Tai's work during the previous Administration, the USMCA raised the bar over any previous agreement when it comes to labor and the environment. He is also, before we close on a matter of I think important competitiveness for our country, a leader on digital trade. He has also been active on transparency and accountability issues.

These two trade nominees are, in my view, going to build out an excellent trade team at the USTR. Both are highly experienced and knowledgeable. Based on the hearing, it is clear that both share Ambassador Tai's commitments to bringing both sides together around policies that, in my characterization, are about trade done right.

With Ambassador having been confirmed by a very close vote of 98 to nothing, it is clear there is a strong interest in bipartisan trade. So I intend to support both of the nominees. I hope colleagues will do the same.

4	Senator Crapo. Thank you, Mr. Chairman. We are
5	here to vote on the nominations of Ms. Bianchi and Mr.
6	White as Deputy U.S. Trade Representatives and on the
7	nomination of Dr. Egorin as HHS Assistant Secretary for
8	Legislation.
9	I intend to support all three nominations. However,
10	today also highlights the Administration has yet to
11	nominate anyone to fill a number of vacancies critical
12	to ensuring that the United States has an effective
13	trade policy.
14	With respect to the Office of the U.S. Trade
15	Representative, those positions include the Chief IP
16	Negotiator, the Chief Agriculture Negotiator, and the
17	U.S. Ambassador to the World Trade Organization.
18	To press forward to a successful economic recovery,
19	we need now, more than ever, to tear down barriers
20	between our businesses, farmers, and workers and the
21	billions of customers beyond our borders.
22	With respect to my votes for the trade nominees,
23	each stress they intend to work closely with Congress,
24	and Mr. White further assured us at his confirmation
25	hearing that he would do so promptly. I appreciate

1	that. But the Administration's continuing efforts to
2	support a waiver for the WTO TRIPS Agreement to fail in
3	regard to any consultation with Congress, prompt or
4	otherwise, the decision to go it alone two months ago
5	raises a number of significant concerns, including
6	whether the Administration will even try to prevent
7	extending any potential waiver to China and Russia.
8	We still do not know, and it is contrary to
9	Ambassador Tai's own statement to this committee in May,
10	whether she would consult before and after each round of
11	negotiations. Ms. Bianchi and Mr. White, I expect that,
12	if confirmed, you will relate to your Administration
13	colleagues they need to do better, especially when the
14	Constitution provides that Congress is not just the
15	potential partner when it comes to its own trade
16	agreements, it is the boss.
17	Dr. Egorin has expressed a clear understanding of
18	the importance of a strong working relationship with
19	Congress. As a veteran staffer of the White House of
20	the House Ways and Means Committee, Dr. Egorin garnered
21	the support and recommendation of both Chair Neal and
22	Ranking Member Brady, as well as their respective staff.

I appreciated Dr. Egorin's commitment in the hearing and in answers to QFRs to being responsive and transparent, and I intend to support her nomination.

1	The Administration could just have an agenda on
2	digital trade and make success, and it would be very
3	much a foot towards the future of resolving issues for a
4	very big part of our economy.

So I hope Mr. White will bring that perspective and knowledge from the Pacific Northwest to the table with the Administration. I definitely think that our trade policies need to be done from the top rung of the ladder. That is, that the United States should be advocating trade policy in a variety of ways. The fact that 95 percent of consumers live outside of the United States, and if we want to grow our economy, we are going to have to grow the trade economy, and we are going to have to grow the export economy.

So I hope that we move these nominees quickly, and that we build the team at USTR. You know, Mr. Chairman, we worked with you on capacity building at USTR, on a resolution of these issues that we did with our colleague, the former Speaker of the House, to build capacity at USTR. That is, to give them more lawyers to resolve trade disputes. The results were phenomenal. The more people we had addressing trade injustices in the international community, the more success we had in getting our products or our exports in the door.

So I am all for USTR being an agency of the future
