OPENING STATEMENT OF HON. ORRIN G. HATCH, A U.S. SENATOR 1 2 FROM UTAH, CHAIRMAN, COMMITTEE ON FINANCE 3 The Chairman. The committee will come to order. 5 are here this morning under extraordinary circumstances. 6 The Senate Finance Committee has a long, storied 7 tradition for temperance and bipartisanship. In times of 8 fierce political and partisan conflict when Congress has 9 found itself facing seemingly insurmountable tension and 10 gridlock, the Senate Finance Committee has always been 11 the exception. 12 That tradition of this committee was, for the first 1.3 time in modern history, broken yesterday as our 14 colleagues, without notice and without warning, opted to 15 stage a publicity stunt in the hallway instead of sitting 16 here at the dais and doing their jobs. 17 Their unprecedented boycott has left us with 18 precious few options. These are important nominations to 19 positions that desperately need to be filled. It is also 20 important that we do not set a precedent that allows the 21 customary good faith that has historically governed the 22 operations of this committee to be cast aside whenever 23 one side wants to gain a political advantage. 2.4 With those concerns in mind, I recognize Senator 25 Isakson to make a unanimous consent request.

Senator Isakson. Mr. Chairman, I ask unanimous 1 2 consent that we temporarily suspend the rule for and all 3 other applicable Finance Committee rules or procedure to report out the nominations of Steven Mnuchin as Secretary 5 of Treasury and Dr. Thomas Price as Secretary of Health 6 and Human Services, and that all other rules come back in 7 operation at the conclusion of today's vote. 8 The Chairman. However, under Rule 19 the committee may opt to 5 suspend any of its rules at any time. 6 Senator Isakson asked for unanimous consent to 7 suspend Rule 4 and all applicable rules for the purpose 8 of voting on these nominees. The request was agreed to 9 after a successful appeal to my ruling on its 10 germaneness, making the quorum requirements of Rule 4 and 11 all other rules that could prevent a vote on these 12 nominations, inapplicable. We then proceeded to vote on the nominations. 13 14 the record, I will note that the Senate Parliamentarian 15 Office has confirmed that this course of action is consistent with both the committee and Senate rules. 16 17 I will also note for the record that every 18 Republican member of the committee was present and 19 voting, exceeding the one-third requirement for a quorum 20 under Rule 4. 21 The only thing missing was a member from the 22 minority side. - 21 First, I will remark on the action that was just
- taken because I am fairly certain our colleagues will try
- 23 to characterize it as some kind of nefarious breach of
- 24 protocol. So before the Democrats call another press
- conference, here are the facts.

Throughout the process of vetting and considering
these nominations, I made a good-faith effort to address
my colleagues' concerns, including extended questioning
periods, both during the hearings and in writing. Yet at
every step, the nomination process has been undermined by
political gamesmanship.

One of many examples includes leaking typically

One of many examples includes leaking typically private disclosures from the nominees to the media in order to build public cases against them. Not very good public cases, by the way.

There have been challenges made about the nominees' ethics, finances and integrity. Yet in each case, the allegations proved to be misleading and dramatically overstated.

Case in point: With Dr. Price, we have heard repeatedly that he was offered and accepted a sweetheart investment deal from an Australian biomed company. But the truth is that the company had a very small group of initial U.S. investors at that time and everyone in that group, you can call it a, quote, "select group," unquote, if you want, were all offered the same access to the stock purchases. Dr. Price's account of the investment has not really been substantially refuted, let alone disproven.

But my colleagues claim, there on the other side,

claim that their misinterpretation of his testimony is 1 2 grounds for an indefinite delay on his confirmation. 3 With Mr. Mnuchin, we have heard a lot about, quote, "robo-signing," unquote, in the past couple of days. What we have not heard is a fixed definition as to what 5 6 constitutes, quote, "robo-signing," unquote. That is 7 because no fixed definition exists. It is a vaque label 8 casually thrown around to refer to a broad set of 9 practices. There is no agreed-upon standard, legal or otherwise, as to what constitutes, quote, "robo-signing," 10 11 unquote. Therefore, any question that simply throws out 12 the term without specifically explaining what is meant by 13 it is not only poorly written, it is inherently vague. 14 In his answer to a colleague's vague written 15 question, Mr. Mnuchin stated that OneWest did not engage 16 in the practice and referred to a government review of 17 practices that provide an analogue for the loose notion of, quote, "robo-signing," unquote. 18 According to the measures utilized in that review, 19 20 OneWest did not engage in, quote, "robo-signing," unquote. In other words, Mr. Mnuchin provided an honest 21 22 answer. This is the level of minutiae we are dealing 23 with here. It is damned irritating. 2.4 My colleagues are using their own parsed words and 25 vague questions as justification for their refusal to

even vote on these nominations. As a result, we are 1 2 currently in the midst of the longest transition period 3 without a confirmed treasury secretary in our nation's history. 4 And the process for vetting and reporting Dr. 5 6 Price's nomination has taken longer than that of the last 7 two HHS secretaries combined. Of course, Democrat 8 secretaries. At every turn, my colleagues' arguments 9 change, but their answer is always the same: Delay. 10 And then yesterday, my colleagues took the unprecedented step of boycotting a Finance Committee vote 11 12 on nominations. Long story short, we took some 1.3 unprecedented actions today due to the unprecedented 14 obstruction on the part of our colleagues. 15 As I noted earlier, the Senate Finance Committee has 16 traditionally been able to function in even the most 17 divisive political environments. That all changed 18 yesterday. 19 Personally, as a longtime member of this committee, 20 I have been proud of that distinction. And in my time as 21 both ranking member and chairman of this committee, I 22 have bent over backwards to preserve its unique status as 23 one of the few places where Republicans and Democrats not 2.4 only work together, but achieve results. And I defy 25 anyone to give an example of a time when I have done

1 otherwise.

Now, I get that my colleagues think these nominees are controversial. I get that they do not want to see them confirmed. We have all been in that situation. It comes part and parcel with the job of being a senator, and this is hardly the first time a nominee deemed to be controversial has come before this committee.

I will remind everyone that nine years ago this committee processed a treasury secretary nominee that was highly controversial. He had an outstanding tax bill of nearly \$40,000, as much as many Americans make in a year, and for some of our colleagues his explanation for the unpaid taxes did not seem to add up. And he was appointed by a president that our side did not support and with whom we had serious, and I mean serious, disagreements. Yet even then, Republicans on this committee showed up to do their jobs.

Yesterday, rather than accept anything less than their desired outcome, our Democrat colleagues chose to cower in the hallway and hold a press conference. To make matters worse, our colleagues did all of this despite the fact that the ranking member and I had worked through the process together on these nominations and had agreed upon a timeline for votes.

I had, of course, foolishly assumed my colleague was

operating in good faith. Worse still, the decision to 1 2 boycott yesterday's meeting was not conveyed to anyone on 3 our side until literally seconds before we were scheduled to begin. And the decision was not even conveyed to us 5 by the ranking member in person. 6 While clearly I am frustrated by this turn of 7 events, I am actually more confused than anything else. 8 The senator who led this boycott is the same ranking 9 member who worked with us on the committee to report and 10 eventually pass a record number of bipartisan bills in 11 the last Congress. It is the same ranking member that 12 defied many of his own party to draft support and help 1.3 pass historic trade legislation in 2015. It is the same 14 ranking member with whom we have been able to navigate a 15 number of dicey political issues, including, for example, 16 our investigation into the IRS targeting schedule. 17 Today, the ranking member, who did all of those 18 things, is nowhere to be found. For all intents and 19 purposes, the Democrat seats on the Finance Committee are 20 all now occupied by the Senate minority leader and all of 21 them appear ready to leap off whatever cliff he 22 designates, even if it means breaching the good faith 23 that has long been the hallmark of this committee. 2.4 Needless to say, this discussion is not over. 25 intend to get the committee back to where it once was and

- 1 I will use every tool at my disposal, procedural or
- 2 otherwise, to make sure this does not become the new
- 3 normal for the Senate Finance Committee.

Chuck Grassley Mnuchin-Price Markup

I am disappointed in the actions of our colleagues on the other side of the aisle. Denying this Committee the opportunity to process two members of the President's cabinet is unprecedented. This is blatant obstruction, plain and simple.

The Finance Committee has a long tradition of collegiality and bipartisanship. As someone who has served as both Chairman and Ranking Member of this Committee, this tradition of the Committee is something I have long taken pride in.

Senator Baucus and I always worked together to ensure the proper functioning of this Committee regardless of who was Chairman or which party controlled the White House. In fact, Senator Baucus and I had an agreement that each would provide the needed minority member if necessary at a markup.

This is why I am so disgusted that rank partisanship has infected this Committee as evidenced by the political stunt by our colleagues on the other-side.

When President Obama was elected in 2008, many on our side were deeply disappointed. But, we did not seek to impair the functioning of this Committee.

In fact, we diligently got to work to ensure President Obama had the appointees in place that were necessary for his Administration to function.

A nomination hearing of Treasury Secretary Geithner was held the day after President Obama was inaugurated. Within 24 hours of Secretary Geithner's hearing, the Committee once again met to report his nomination to the floor.

Thank you, Mr. Chairman. I understand why you needed to move forward with this markup today. This committee has a proud history of bipartisanship and it is unfortunate that the Minority on this committee have left us with no choice. I am hopeful that this is not indicative of where this committee will go moving forward in this new Congress.

Reporting each of these nominees out of Committee, this morning, will allow us to start working on the issues that the American people sent us to Washington to do.

After many discussions with Treasury Secretary nominee Steven Mnuchin, I received answers to my specific concerns pertaining to the devastating housing crisis in Nevada. As we all know, this was a very difficult time in Nevada's history, and any time a home is foreclosed on, it is a painful experience for those affected. That's why I want to look forward and ensure this doesn't happen again. We can either stare at the darkness of the past or we can focus our attention forward to the future where a strong economy and job creation are placed at the top of the Administration's new pro-economic agenda. I secured the nominee's commitment to help struggling Nevadans by supporting commonsense initiatives, such as the Mortgage Debt Relief Act, and in relieving the tax burden of the middle class by committing to help repeal the Cadillac tax. I look forward to working with him as our Treasury Secretary as we enact policies focused on a devotion to economic growth not just in Nevada, but across our the entire nation.

I also want to thank Congressman Price for his willingness to work with Nevada on the important issue of protecting access to health care for all Nevadans, and please know that if confirmed, as HHS Secretary, I will hold you accountable for the promises made to me and to Nevadans that you will work to protect access to quality, affordable health care, including those on Medicaid. In his answers to my questions in the hearing, as well as in his written answers, Congressman Price emphasized that he will work with Congress and States to protect access to care for all patients, including patients with a pre-existing conditions or on a fixed income. In the hearing last week, Congressman Price also made it clear that he believed that the Cadillac tax was a tax on the middle class and said he would work with Congress to repeal it. This tax would affect 1.3 million Nevadans. This includes culinary and service industry workers on the Las Vegas strip, public employees in Carson City, small business owners, seniors, and teachers. With nearly unanimous support in Congress and a commitment from the Treasury Secretary and the Health Secretary, I am confident that together we can repeal the 40 percent excise tax.

With that, I thank the Chairman and the Ranking Member for the time to discuss issues important to the Silver State. I look forward to working with Mr. Mnuchin and Dr. Price to enact policies which spur economic growth, create jobs, and protect access to health care in Nevada.
