3 Senators have been present this morning, and accordingly
4 it would be in order, I believe, and it is the view of the
5 Ranking Member that we have had a rolling quorum having
6 been established, the Chair proposes the following
7 nominations to be reported, with the recommendation that
8 each be confirmed.

9 Ronald K. Nobel of New York, Assistant Secretary of
10 the Treasury; Leslie B. Samuels of New York, to be
11 Assistant Secretary of the Treasury; and Frank N. Newman
12 of California to be an Under Secretary of the Treasury;
13 and Jack Duvore of Texas to be an Assistant Secretary of
14 the Treasury.

15 There is a second. All in favor will say aye.

16 (A chorus of ayes.)

17 The Chairman. The ayes have it. Is there any
18 opposition?

19 (No response.)

20 The Chairman. There is none.

21 Unanimously the Department nominees are reported out.
22 Mr. Samuels, your prospects look better by the day.

23 (Laughter.)

25 The Chairman. Thank you, Mr. Mitchell. I know it


