- 1 OPENING STATEMENT OF HON. CHARLES E. GRASSLEY, A U.S.
- 2 SENATOR FROM IOWA, CHAIRMAN, COMMITTEE ON FINANCE

- 4 Senator Grassley. The meeting will come to order.
- 5 Good afternoon. Yesterday we met in open executive
- 6 session to review and make recommendations on proposed
- 7 legislation implementing the U.S.-Australia Free Trade
- 8 Agreement Act. We were unable to complete our work
- 9 yesterday, so we are continuing the executive session
- 10 this afternoon.
- 11 Today we will be voting on whether to consider
- 12 favorably approving the committee's recommendation, as
- amended. Let me first say that I strongly support this
- 14 agreement. While it may not be perfect, it is a solid
- 15 agreement that will bring significant benefits o the
- 16 United States and my home State of Iowa.
- 17 I also support the bulk of the implementing
- 18 legislation that we reviewed yesterday. In fact, Senator
- 19 Baucus and I worked closely together with the White House
- 20 and the House of Representatives to make improvements to
- 21 the legislation in an attempt to craft an implementing
- 22 bill that would receive broad bipartisan support.
- 23 Unfortunately, during our informal committee review, an
- 24 amendment was very narrowly adopted to the committee
- 25 recommendations which I simply cannot support.

1	This amendment would make the exercise of the beef
2	safeguard waivers subject to approval of the Finance
3	Committee and Ways and Means Committees. While not
4	binding, this amendment, according to a legal analysis
5	provide by the impartial and bipartisan Congressional
6	Research Service, violates the U.S. constitution. I ask
7	that this analysis be included in the record.
8	[The analysis is appended to the transcript.]
9	The Chairman. I cannot in good conscience recommend
10	that the President include an unconstitutional provision
11	in the formal implementing bill, and for that reason
12	alone am voting "no" on our recommendation today.
13	Therefore, we will not be sending a favorable
14	recommendation on the committee-amended product.
.15	I understand that the House of Representatives
16	favorably reviewed the proposed legislation which is
17	identical to the bill we have before us today, but
18	without the constitutional infirmities caused by the
19	adoption of the Conrad amendment.
20	I highly recommend the favorable consideration of the
21	House legislation reviewed by the administration.
22	I move that the committee now consider favorably
23	approving the committee's recommendation, as amended, to
24	implement the U.SAustralia Free Trade Agreement. I
25	vote no.
