

Hello -- I have asked my mother and guardian to type this story because I am not good at that. I want you to know that I am disabled. I have a lot of things that are very hard: cystic fibrosis which also includes asthma, CF-related diabetes, and allergies including allergic bronchopulmonary aspergillosis. Plus, I have three X chromosomes, which is called Trisomy X, and which means I have several very serious learning disabilities and cognitive delays. I also am on the Austism spectrum and am what my doctor calls 'developmentally delayed'. And I have two mental health conditions called mood disorders: Depression and Severe Anxiety. All of these conditions can make it very hard to learn at the same rate that other people do, to understand what's happening around me, and to control my emotions. I've worked very hard to learn about my disabilities and how to be a good person, and I very much want to get a job so I can help my mom and dad with bills and also have fun. I have been on Medicaid since I was almost 2 and a 1/2. It was very important because I have been in the hospital a lot for my cystic fibrosis, and my mom and dad could never have afforded all those bills. I see lots of doctors, and I have all my life. But my doctors work hard to communicate with each other, and my caregivers work hard too. Today, I am twenty years old. Without Medicaid, I would not have the good pulmonary health I have now; I would not be able to attend the day programs and high school transition programs I attend, where I learn more about how to find and be good at a job; I would not have the medical care at all that I need, including behavioral therapies that help me learn and practice skills that will help me be safe and healthy -- they are hard for me, so I have to practice them a lot -- and CF-related care that helps me deal with many, many things that are hard for my body. Medicaid also allows me to live and work in the community through the Home and Community Based Services -- as a child I would not have survived or my parents would have been bankrupt without these services, and today as an adult I would not have the medical care and would not survive long, nor would I be able to interact in the community and continue learning and contributing (I volunteer each week at the Arc and other businesses). I would like the Senators to know that Medicaid is very important. My mom tells me that it's also actually quite efficient and has 'good outcomes'. I am one of those outcomes. If you don't want people like to live anymore, then go ahead and kill Medicaid. But at least be honest, that when you do that you will be killing people, not giving them more freedom or choice -- those kinds of statements are lies and are mean. Hello! My daughter is entirely dependent on Medicaid. She has been a recipient of the Home and Community Based Medicaid waivers in Colorado since she was around 2.5. She is 20 now. She has a plethora of conditions that cause her to be disabled, that is, unable to learn and interact at the same speeds as peers, and is constantly dealing with significant and progressive medical and mental health issues related to Cystic Fibrosis and Trisomy X. She is on Autism spectrum and also intellectually delayed and struggles to understand the interactions going on around her with peers. She also experiences severe anxiety and depression, and often has trouble expressing her frustrations, disappointments and concerns appropriately. Without Medicaid HCBS children's programs during her childhood, our family would have been destitute. Even with Medicaid, her care is very time-consuming and stressful, impacting my ability to work for the last twenty years, reducing my productivity and adding to my own stress and health concerns. Without the adult HCBS Medicaid programs, she would be indigent and possibly homeless due to my own stress-related illness and she would be at extreme risk of exploitation, hard, violence and early death. Medicaid is one of the most efficient and effective mechanisms for caring for people with complex medical and developmental needs. The efforts of Medicaid providers to coordinate care, reduce bureaucracy as allowed by law, and focus on appropriate and cost-effective care and living options is truly profoundly impressive. Dismantling Medicaid will cause extreme hardship to the millions of families living with a disabled and/or chronically ill loved one. I urge the Senate to get focused on creating legislation that works rather than rolling back the clock on programs that are actually reducing costs through early and less costly interventions, and also thereby starting to improve recipient productivity since people's health issues are taken care of and their and their loved ones' health can improve. I am on the Medicaid Buy in program which is a program created by Colorado to give working adults with disabilities Medicaid through a buy in. We pay a monthly premium depending on our income and in exchange, we are able to access healthcare. With this program, I am able to continue working with my disability and afford the health care I need. I work for a small non profit working with people with all types of disabilities with no benefits. Without this program, I will be unable to work and unable to afford premiums. If you cap Medicaid or block grant it, creative programs like this one will be gone. The opportunity created for adults with disabilities to work while being able to affordably access health care will be gone. Before the Affordable Care Act, I went 7 years without insurance. Due to my disabling conditions, I was out of work and on Medicaid through the expansion for a while and without insurance, I would have had no treatment for my chronic disabling conditions.

My daughter is on Medicaid through the Medicaid expansion under the ACA. She has multiple disabilities and is waiting on the long process to get Social Security disability benefits. With the Medicaid expansion, my daughter has been able to access the mental and physical health care she needs. Without this program, she would be medically bankrupt at 25 and in an even worse position than she is already. Before the Medicaid expansion, I saw people like her unable to access healthcare and saw them literally die without access to the specialized care they needed. This is not an exaggeration. The Medicaid expansion has been one of the biggest blessings to my daughter and many people with disabilities that has happened in a long time. Please do not destroy this blessing.

I am terrified about what could happen to both of us if this bill passes. This could be devastating to my family and many other families around the country that rely on Medicaid.

He has a contagious smile and before his tracheotomy surgery this summer, he had a wonderful giggle. Our son has a good quality of life, who is loved by his family. His life is full and is able to live at home because of Medicaid. He is on a Medicaid waiver that is in jeopardy if this new bill before the Senate is passed. Optional Medicaid waivers would be the first to go. This bill will eliminate the Federal matching funds that are used to help fund the waiver programs like the one my son is on. My son needs nursing home level of care, yet he is currently able to live in our family home, because we have the help of nurses and therapists who come to our home to treat and care for his needs. Please do not force my son to go to a nursing home, a very inappropriate place for him to live, just because Medicaid will be drastically cut if this bill passes the Senate. It is much less expensive and much more efficient to allow my son to continue to live in our home, than it would cost to have him in a nursing home. Please allow him to continue to live in our home, it will cost tax payers less money for him to stay in our home. Cutting Medicaid drastically as this bill would do, will actually cost much more for my son's care, if he is forced into an institution to get nursing care. This bill is being pushed through the senate, without hearings, without public testimony, without even time for Senators to research it well. This is not responsible governing. When my son, Max, had just turned a year old he was admitted into Children's Hospital Colorado for a month due to a severe allergic reaction to the flu vaccine. Max was born with a very rare metabolic disease called Cobalamin X, which was identified first in him as a new disease by doctors and scientists at University of Colorado and Children's Hospital. Max also has a severe form of epilepsy. Because of his multiple disabilities, the reaction to the flu vaccine caused many complications, including respiratory failure. In the month Max was in the pediatric ICU, they tried to wean him off of the vent that was breathing for him, but he could not breathe on his own, so a surgery was scheduled to put in a permanent tracheal tube and a vent would do the breathing for him for the rest of his life.

At this time, we had excellent private insurance and everything was paid for. By the end of Max's first year of life, he had spent over 70 days in the hospital, had had multiple brain surgeries, and had racked up over \$2,000,000.00 in medical bills. We only had to pay a \$25.00 co-pay for bringing him into the ER the first time. When the conversation of Max needing a tracheostomy and a vent to live came up, it didn't matter that we had great insurance. Our excellent insurance only went as far as the hospital walls. If we wanted our baby to live, he would have to live inside the hospital, in an isolation room, on a vent because our insurance wouldn't pay for the in-home care required to have a vent. We were told that in order to take him home, he would have to be on Medicaid, but it would likely take a year for him to be approved because of the long wait-lists for Colorado Medicaid Waivers at the time. We were given the choice to take our baby off the vent and let him die or choose to let him live by giving him the surgery which would mean living in the hospital for a year or more.

We chose the surgery and were starting to come to grips with the fact that we were going to be moving into a hospital with our son to live. We were a middle-class family who made far too much income to qualify for Medicaid and were being forced into living in a hospital with our baby. We had started the process of determination for Max to get Medicaid through a waiver based on his disability and not on our income, and scheduled the tracheostomy surgery for December 1, 2004. That morning before he was taken back to surgery, Max started coughing. He coughed until he had coughed the breathing tube out. By a true miracle, the doctors discovered he was breathing on his own and the surgery was canceled. Within a week, were home with our baby and had avoided living in the hospital until in-home services through Medicaid were in place.

Before the scare of having to live inside the hospital with Max was a reality, we had no intention of putting him on Medicaid. We were ignorant and didn't know it wasn't just a type of insurance for low-income individuals. We didn't know it was also an insurance for children and adults with disabilities like our son. We didn't know he would need it. We didn't know our lives, and everything we were working for could be destroyed without Medicaid. Max has been able to live at home now for 13 years, with a Medicaid waiver and private insurance. He has had many other kisses with death and many more hospital stays. But when he's healthy, he's home - and at home, he's thriving and LIVING. He has been able to get therapies at home throughout the years because of Medicaid. These therapies have allowed him to become stronger, and have given him a way to communicate. Because of Medicaid, we have been able to adapt our home as he's gotten bigger to make it the best living environment he can have. Max is homebound most of the time because of his medical fragility, but when he can get out in the community it is because Medicaid paid for the ramp outside of our house, and the lift into his van. He is able to get to his doctor's appointments, and to the zoo. Medicaid has given him a life. Medicaid is what will continue to give him a quality of life he will not have if cuts and caps are placed.

Max is proud of his abilities. He never says he has disabilities. He says, "I am able." He is proud of every little thing he can do, and we are too. Although he doesn't remember the time when his parents stood crying over his hospital bed having to decide between life and death, begging him to fight and to live, we do. Max chose to fight to live, and because of his fight, we fight to give him the very best life. I implore you to vote NO on the Graham-Cassidy bill. Don't take us back 40 years when people in wheelchairs and with intellectual and developmental disabilities were warehoused in hospitals and nursing homes. Don't take



COLORADO MEDICAID IN ACTION: SAVING LIVES, MAKING A LIFE-CHANGING DIFFERENCE FOR ONE PERSON AT A TIME . This story is about Jess, an infant with Down syndrome, born in Denver to a crack-addicted mother, and given up for adoption in early 1996. The adoption process, initiated through the weekly television-based Wednesday's Child project, was interrupted by a life-threatening event. At nine months Jess developed croup resulting in the need for a tracheotomy due to severe sub-glottal stenosis and tracheomalacia.

Children's Hospital physicians told the pre-adoptive family that the associated mortality rate for these conditions in infants with Down syndrome was significant and that if he survived, the associated morbidity included a life with no speech, and inability to breath without a machine. Jeffco Social Services fast-tracked the months-long adoption process to one week so Jess was released to his new family directly from Children's instead of going to a medical group home. This development would have been impossible without Colorado Medicaid.

Surgeons at Children's Hospital had limited experience with a life-saving operation that would involve severing his vocal chords to repair his trachea. After research, the family found Dr. Robin Cotton, a British surgeon practicing at Cincinnati Children's, who had successfully performed a procedure that widened and stabilized the trachea by suturing a section of rib directly into the windpipe. Following considerable advocacy on the family's part and extensive medical review, Colorado Medicaid approved the surgery in Cincinnati. The family had to wait until Jess weighed almost ten pounds which was challenging due to a failure to thrive diagnosis associated with the tracheostomy. Medicaid private duty nursing assured his medical stability prior to the operation.

Long story short, the operation was a success. Jess' vocal chords were saved. After 18 months of trach-suctioning induced sleepless nights and occasional private duty nursing through Medicaid, Jess was successfully decanulated. Through his childhood and teen years Medicaid Home and Community Based Services (HCBS) have allowed him to build relationships and learn life skills within his community. As a result, he just graduated high school with numerous community connections and will hopefully begin work supported by a job coach paid for through Colorado's HCBS program at Cosmos Pizza or Rincon Del Sol in the fall.

To Whom It May Concern;

I can't tell you how fearful I am in regards to some changes that could be made to Medicaid that will have a severe and profound impact on my family. I have met many families that will also be affected by these changes and they, too share my concern. I not only have one child with disabilities, I have FOUR. All four of my children are covered by insurance that I pay for privately through my employer (I'm one of the lucky ones, and it still costs me almost \$600 per month for insurance). Unfortunately my insurance does not cover everything and there are many gaps in coverage that prevent my children from getting the care they need (insurance that was designed to meet the needs of "normal" families with less extenuating circumstances). Fortunately for us (at least for now) my children have what is called the "Medicaid Buy-in Program for Children with Disabilities" (which I pay an additional \$70 per month for). It covers what my insurance won't. One of my children also has a CES waiver (Children's Extensive Support Services) through Medicaid that pays for things that regular Medicaid does not cover, like care for an individual who cannot be left alone (respite care) so that I can continue caring for him at home. Believe it or not, this is much cheaper than placing him out of the home, as he is at risk of being institutionalized without these services.

It is a tough road having four children with special needs. I am one of thousands of families who depend on Medicaid just to get by, and in some cases, to stay alive. One of my children has been hospitalized over 30 times in the last three years alone. I adopted him and his brother after they were severely abused and neglected by their biological mother. His younger brother, also in my home, is learning to trust again after being sexually victimized by his biological mother's drug buddies when they were still in the home with her. My biological daughter attempted suicide by jamming a belt in between her door frame and the door. Fortunately the belt slipped when she placed her head through the loop and she began struggling for air. She was 13. I have been trying to keep her alive ever since. She battles with a mood disorder and chronic depression; disorders that threaten her life on a daily basis. Every day it is a fight and instead of a belt, she hangs by a thread with supports and services in place. And just like that....they could be taken away. My oldest son has autism, an early onset psychotic disorder, cognitive delays and speech delays. He tried to stab his sister a little over a year ago because the voices told him to do it. He was facing felony charges and out of home placement. In total, my children have been in 7 different hospitals over 50 times in the last three years. I am doing everything I can just to hang on while continuing to fight for the things they need in order to be whole, to be alive, and to be together. They are getting better, but there's still a lot of work to be done.

It is very easy for someone to deny these things happen; that families like mine don't exist and the means to provide access to supports and services aren't necessary. They couldn't be more wrong. This is my reality. This is my life. These are my children and this is my family. We are real, and so are our needs. For as much as I'd like to say I can do it on my own, the reality is I can't. My daughter is alive today because of the therapy she gets, the medications she's on, and the specialists she sees on a regular basis. My son's charges were dropped because the court felt he was getting the help he needed at home with services in place, and that adjudicating him and institutionalizing him was not in his best interest. My adopted son who has been hospitalized over 30 times is finally starting to make gains in treatment because he has access to consistent treatment. My

youngest son just got an in-home therapist that can work with him on his terrible past in a setting that he feels safest in. These are all services that my insurance **DOES NOT COVER!**

Imagine what it would be like to lose your child, standing in your driveway as the ambulance drives away. You wonder if there's something you could have done better, or different as the lights trail off in the distance. You get in your car to follow and along the way your head is swimming. You wonder what could be so bad that your oldest child would rather die, than find a way to survive in this world. You wonder how someone could hurt their children so bad that it would cause them to act out violently and how helpless it is to feel that you've done everything you can and it's not enough. Your love.... just wasn't enough. You wonder how you could have comforted a child who is frightened any better than you already have when they are hearing voices telling them to hurt others. All of these things go through your mind, and you know what? The one thing I haven't had to worry about up until this point is how is all of this going to be paid for? As long as my children have had Medicaid I didn't have to worry about the cost of their treatment, or whether or not they'd get the help they needed when my insurance alone wasn't enough. When my love wasn't enough. Medicaid is the reason we still have a home and are not living out on the streets. It is the reason I could take on two additional children instead of them being "raised" in the foster care system.

Medicaid is more than just the cost of care. It is keeping families like mine in tact. It is keeping children in the home where they belong instead of some facility, committed in the youth correctional system, or out on the streets. It frees up my mind as a parent to focus on what really matters - my children. Doesn't your family matter to you? Does my family matter any less? Please, do what you can, whatever is under your control to stop this from happening. YOU have the ability to help families like mine. To me, this is putting a price tag on my daughter's life and it is law makers telling me that her life isn't worth the money it takes to get her the help she needs. That is wrong. Please, I don't want to bury my child any more than you want to bury yours. I don't want to lose my sons who struggle just to stay in my home where they are loved and cared for. I would lose them just because I can't afford their medical bills. What is it worth to you and others who have the power to make a difference? Please, do the right thing. Keep Medicaid. Keep supports and services accessible to those who need it most. Thank you.

My daughter is 26 years old. She lives with us at home. I am her primary care giver - still and will be until I die and then I do not who will care for her. In the meantime and beyond she needs purpose in her life with love, support and guidance. She gets that through her current Medicaid Waiver - which provides an opportunity for her to participate in:

- 1. a pre-vocational program during the day M-F.
- 2. therapy that teaches her how to manage her anxiety and
- 3. homemaker skills training

Through NO fault of her own (or mine) she was born with low muscle tone, an autism spectrum disorder, anxiety, sensory processing disorder, epilepsy, etc., etc., etc. She tries to work at volunteer jobs - but is not successful - yet. We would absolutely LOVE for her to be able to care for herself, like her 23 year old sister is able to do. The difference is in the ability piece. Desire and ability are not the same thing - reality is such that she can not work. Thus, she is dependent on Medicaid.

Additionally, Medicaid Medical is vital to her health: Preventative care now will always cost less later.




My son is 19, and he has severe cerebral palsy, which causes him to have breathing problems, he has a g- tube for feeding, and has to use a wheelchair to get around. He is non-verbal, so needs a communication device to communicate at school. My son needs to have Medicaid as a secondary insurance, in order to have his many medical needs met. As I told you earlier, my son currently lives in our home, with us, his family. We are able to make this work, because I am his paid family caregiver. He is not in a group home, he lives in our home. Here he gets nursing and loving family care. If there are cuts to Colorado's Medicaid money, he may be forced into a much more institutional type setting. In such a place, he would not get one on one care, as he does in our home. He would be much more likely to be at risk of dying due to lack of care, due to poor care, and poor oversight. Institutional care actually costs much more than it does to care for my son at home, with his family. We as a family, would never be able to afford all of his nursing care, his medications, his surgeries, and therapies, if we had to rely on our private insurance alone. On June 15 he got a tracheotomy. He currently qualifies for 24 hour nursing care. It is cheaper to care for him in our home than in a nursing home. Please do not force him to go to a nursing home to get nursing care.

This new BRCA bill will decimate Medicaid, with cuts as much as \$800 billion in cuts. If that much is cut from Medicaid, at the federal level, Colorado will never be able to come up with the portion that the Federal Government now pays for. As a result, the waitlists for services in Colorado, will grow very long, again. The Medicaid money that is available to people in Colorado will have to be reapportioned between, disabled, elderly and poor. Some of these groups or all of these groups will lose services, and or coverage.

Please, do not vote for this bill as it stands. It does not protect people with pre-existing conditions, it does not protect the most vulnerable of our society, the disabled, the elderly, and the poor. In my opinion, we should not balance the budget on the backs of the most vulnerable of our society. We voted for you to be our Senator. Please do the right thing and vote no.

Our Medicaid is essential to our survival. Thank you for delivering this email on my behalf.

I spent the first 35 years of my life earning my own living and getting my education. I started working in family businesses when I was six years old. I worked throughout High School, and while I put myself through college. I paid taxes and bought my own health insurance. I paid for my education. At the age of 30, my son was born prematurely and diagnosed with cerebral palsy. He would need a lifetime of constant care. I continued working as my husband cared for him, because my job had the health insurance. I paid for everything for my son until he was 18 including wheelchairs and his health insurance.

When my son was released from the school system at the age of 21, my husband was no longer able to be a full-time caregiver so I left a position with an executive level salary. I went to work for a home health agency where I am paid less than \$35K per year to provide home care for my son as his Certified Nursing Assistant. My company, Personal Assistance Services of Colorado, still provides health insurance for me but my son must rely on Medicaid and since his Dad retired, Medicare also. I still pay taxes on my income.

We are not looking for a hand-out, just assistance and maybe a little return for all that I have contributed through taxes and community services. We live in a very small home and my husband did all the modification so that it is accessible. The medical insurance and community based services that Medicaid currently covers allows my son to thrive in the community but he cannot do this independently yet. Without vital Medicaid waivers and health insurance, we would not be able to keep our home, health, and livelihood. What would you want if you found yourself in a similar situation with rising food, living and healthcare costs and the need to care for your 28-year-old son with a significant disability?

To institutionalize her would slight the entire population—and her, especially.

Medicaid provides jobs to others. Eliminating it will leave a huge population of care providers without income. Many will qualify for federal supports, when they'd rather be working.

Columbine Health Systems provides senior care services and facilities for older adults in Northern Colorado since 1971. As the Human Resources Director for Columbine Health Systems, with a 1500 employee base, I am in charge or hiring a wide range of positions with an average of 30 jobs monthly available. This can be difficult in a city with the exceptionally low unemployment rate of 2.2%.

Starting in 2011, we partnered with Project SEARCH International, Poudre School District, Colorado State University, and Center for Community Partnerships. Project SEARCH brings High School Students with significant disabilities into our job sites for internships and other employment-related experiences. The program has an 80% success rate of students with significant disabilities graduating with a job within our organization or the community that pays at or more than minimum wage. This stands in stark contrast to the roughly 80% of working-age people with significant disabilities who are not working in Colorado.

Because of the success of Project SEARCH, we now have a diverse workforce, including many people with significant disabilities. I am concerned about the supports those employees with disabilities may lose if Medicaid is capped or cut.

While Project SEARCH works on helping young adults with significant disabilities obtain employment, Medicaid provides long-term support so that person can stay employed after he/she has graduated from the Project SEARCH program. Medicaid waivers can provide personal care, transportation, and even job coaches so employees with disabilities have the support they need to be successful in the workplace. If Medicaid is capped or cut, those benefits may be cut, leaving the people with disabilities who work for Columbine Health Systems without the support they need to work. It is critical for this support system be in place for successful long term employment. Retention is our focus at Columbine Health Systems.

Please vote no on any bill that cuts or caps Medicaid!

I am writing to you again to tell you what Medicare means to me, here in the state of Colorado.

I was diagnosed with relapsing/remitting Multiple Sclerosis in May of 2002. I had a sudden, unexplained fall in my home, from which I also endured closed head brain injury. Months of memory loss, loss of motor skills, all of which required multiple therapies just to recover from the brain injury. My PCP ordered an MRI, which discovered that what had caused the fall was Multiple Sclerosis. During the years that have passed, MS has raged it's attack on my central nervous system. At this point and time with my incurable disease, I am no longer relapsing/remitting MS - I have moved into another form of the disease which is Secondary Progressive MS. I have endured significant physical disabilities that require both physical & occupational therapy. I need assistance with most daily activities- even as simple as cooking, dressing, and bathing. I have endured many bouts of optic neuritis to the point that both of my optic nerves have been destroyed, and I am essentially blind. My care is complex, and requires that I have a team of medical professionals to make sure that I get the care I need. I rely on Medicaid to cover the expenses for the care that I require.

I am able to live independently in the community, and contribute to the community while my husband is able to be my care provider for me. Here in Colorado, I not only rely on Medicaid, but also on Long Term Supports & Services. I am able to be cared for by my husband, rather than placed in a nursing home. I am only 53 years old, and I cannot possibly understand how it would be more cost effective to place me in a nursing home, nor can I even imagine not having access to any health care.

There is no other insurance option for me, nor is there anything that I am able to transition to. I am a real person, with a disease that I did not ask for, trying to fight against the disease. Never did I imagine that I would have to fight against a plan by Republicans that would essentially "gut" Medicaid. If that happens, and Medicaid is gutted, I am left in terror as to what will become of my health, and life.

I am asking you respectfully to please vote no on this new reboot to health care. While I do as knowledge that Obamacare did not fix everything for everyone, why does it all need to be dismantled? Health care reform is not something that you just shove through so that campaign promises can be met - we are talking about millions of people being unable to access or afford health care. How are we "making America great again", while in the process millions of people will face immediate life and death consequences? What Medicaid Means to Me:

I have been on Medicaid for 24 years. The two years before I had Medicaid, I had 14 hospitalizations. I was uninsured and uninsurable so those blls never got paid. Since I have had Medicaid I have not spent one night in a hospital. Colorado now has a Medicaid buy-in program for working adults with disabilities. I was forced to go on Social Security Disability in my 20's for the purpose of getting Medicaid Home and Community Based Services. I was so sick from not having care that doctors were refusing to treat me unless I got on Medicaid. When Colorado allowed us to work, and pay into Medicaid, I jumped at the chance. I now pay a premium for Medicaid and happily gave up SSDI. Over 7000 of us have started working in Colorado thanks to this program. We do not want it taken awat

Medicaid allows me to get services that I need to work. This includes a decent, durable power wheelchair, personal care attendants to help with showering and other personal care, and medical supplies. Once my Medicare stops (7 years from when I ended SSDI) then Medicaid will cover medical bills. Most of what I need is not available with insurance, even the best insurance. Insurance only covers \$2500 for durable medical equipment. That would not even cover repairs for a year let alone a wheelchair. No insurance covers long term services like personal care.

Colorado Medicaid does a lot to make the program sustainable. Our accountable care collaborative has brought down emergency room use and inpatient hospital care in just a few years. Allowing consumer directed personal care improves quality by letting the client directly hire and train our in home workers. We do so with a rate 10.75% less than agencies. There are many more examples. Colorado Medicaid has made these improvements with optional benefits. If the budget is slashed they will not be able to use these optional benefits or do anything creative.

Medicaid is important to me, I have friends who will die in days if their Medicaid is interupted. Friends that use ventilators need care every hour of every day. I have several friends with ventilators and other friends with very severe disabilities and they will die with per capita caps. Medicaid is the lifeline to so many and taking it away means that people with disabilities cannot be assured that we have a right to life, liberty or the pursuit of happiness.

My husband and I are aging parents of a 21 year old son with Down syndrome and other disabilities. He had a rare congenital condition requiring airway reconstruction as an infant, with less than a 1% survival morbidity rate. After 12 surgeries (paid for through Medicaid) to build a new airway, he was a thriving cheerful two year old and at that point, the courts approved our adoption from county social services. During this first 18 months that he lived with us, Medicaid paid for his medical equipment, medications, in-home therapies, doctor's visits, and some nursing for his tracheostomy care. In other words, what it took to save his life. After going through neighborhood schools included with his neighborhood peers, he graduated last May with over one hundred friends celebrating at his graduation party. He now volunteers in the community through several nonprofits and is learning more and more skills to get a job and contribute even more by paying taxes and being a valued member of his community. He is truly loved by his family and extended family and neighbors and friends. His life is a miracle and a gift. I did not mention that he did not learn to read or write or count, has a significant speech and communication disability and a very severe cognitive disability which makes daily living and self-care skills impossible without support. He cannot safely cross the street yet he loves life in the community. He has Medicaid to support about 20 hours of his weekly activities in the community. He will need lifelong support, more after his Dad and I are deceased or no longer able to care for him. Without these services and supports, he will be lonely, isolated and at risk for institutionalization, not safe or secure in any way. I implore all legislators to vote NO on the current health care act destined to destroy my son's life and many thousands of lives through such drastic Medicaid reductions that are proposed in this Act. Dear Senator Gardner,

In 1972 I worked in a Denver area nursing home that had a special wing that accommodated younger persons (as young as 10 years of age) with severe disabilities. Almost all of the residents preferred living independently, but in 1972, Medicaid community based services were pretty much non-existent. Ironically, Medicaid was the major funding source while these younger individuals were in the nursing home. In 1975 I co-founded a non-profit organization that transitioned dozens of persons with severe disabilities from nursing home to their own homes. Almost all of these individuals were able to live independently or semi-independently as a result of Medicaid funding in the years that followed.

I am 73 years old and had been a provider of home health and related services funded through Medicaid for approximately 40 years. The agencies I directed (both in the non-profit and later in the for profit sector) served very severely disabled adults and children. The major services provided were lifting, bathing, bowel/bladder/skin care, and a host of related services enhancing independence and quality of life. So during that span of 40 years, I was able to see firsthand how persons with severe disabilities thrived when Medicaid funding was available.

Yesterday (July 14, 2017) I was hiking with some friends and we were talking about divorce rates of parents who have or had children with disabilities. One stated that the divorce rate of parents who had children with severe disabilities was exceptionally high. Having been in the field for as long as I have my response was that the divorce rate, as I saw among clients I served, tapered off over the years significantly when Medicaid home health and home and community based services became available. While I saw this change as a provider I experienced this change on a very personal way. In 1992 my then one year old child was diagnosed with a terminal disease. While my daughter died at 3 ½, I was very involved in the organization (National Tay-Sachs and Allied Diseases) for over seven years. I knew well over 100 families and can say that the divorce rate among them was slightly below the national average. For sure there were strains on marriages, however, when resources were available, primarily through Medicaid, those strains were lessened, oftentimes significantly. I am extremely fearful that the proposed cuts to Medicaid will not only hurt persons with disabilities, but their families as well. I urge you to vote NO to the pending Better Care Reconciliation Act (BRCA).

I have a son and a grandson who both have Asperger Syndrome, which affects is cognitive functioning, and communication and in both their cases they have seizures as well as ADHD. With Medicaid it has kept them on an even keel.

They are both on numerous medications to keep them stable. They are in need of counseling which has also helped in keeping them stable. Both are in need of services to help with their hygiene, house keeping, and our grandson needs extensive med management services. The are both able to live alone together. I am in my 70's and have tried to get services for them so in the event that I am no longer here I know that they will be okay and not under the bridge without their medication. They are both unable to manage their money so at this time I manage their SSI benefits to see that they are both taken care of with dignity and humanity.

I have to say that certain organizations that manage the care of the disabled should be monitored regularly and if not providing the necessary service appropriate to that individual needs or any others individuals needs loose their funding, but Medicaid must remain.

Medicaid does help with their needs such as their mental health services and medication etc. However, Medicaid, I thought was for those who are disabled and not for those who don't work and have children upon children. I know that children are extremely important but those individuals that were born with a disability didn't ask to be that way.

We are attempting to change services from one agency, Blue Skies to The Resource Exchange because, since I have become involved with the Colorado Cross-Disabilities Coalition one of the Advocates mentioned them and I had heard of them but knew they were based in Colorado Springs and had no idea they serviced Pueblo as well.

The change has been difficult as Blue Skies encouraged my grandson to stay with them and when he got home he indicated he was pressured to stay with them. I had been at their meeting then asked to leave and they would call for me when they were ready. When I was brought back in they said he wants to stay with their organization. My husband heard my grandson say he wanted to go with TRE. They even took away his nurse who "quote was supposed to work with him to manage his meds on his own and then transition when if and when it became a habit.

We are supposed to be a humane society and we need to keep that alive. I don't have an answer to those families who continually have children to get welfare but it shouldn't destroy Medicaid for those who are truly disabled.

COLORADO MEDICAID IN ACTION: SAVING LIVES, MAKING A LIFE-CHANGING DIFFERENCE FOR ONE PERSON AT A TIME

This story is about Jess, an infant with Down syndrome, born in Denver to a crack-addicted mother, and given up for adoption in early 1996. The adoption process, initiated through the weekly television-based Wednesday's Child project, was interrupted by a life-threatening event. At nine months Jess developed croup resulting in the need for a tracheotomy due to severe sub-glottal stenosis and tracheomalacia.

Children's Hospital physicians told the pre-adoptive family that the associated mortality rate for these conditions in infants with Down syndrome was significant and that if he survived, the associated morbidity included a life with no speech, and inability to breath without a machine. Jeffco Social Services fast-tracked the months-long adoption process to one week so Jess was released to his new family directly from Children's instead of going to a medical group home. This development would have been impossible without Colorado Medicaid.

Surgeons at Children's Hospital had limited experience with a life-saving operation that would involve severing his vocal chords to repair his trachea. After research, the family found Dr. Robin Cotton, a British surgeon practicing at Cincinnati Children's, who had successfully performed a procedure that widened and stabilized the trachea by suturing a section of rib directly into the windpipe. Following considerable advocacy on the family's part and extensive medical review, Colorado Medicaid approved the surgery in Cincinnati. The family had to wait until Jess weighed almost ten pounds which was challenging due to a failure to thrive diagnosis associated with the tracheostomy. Medicaid private duty nursing assured his medical stability prior to the operation.

Long story short, the operation was a success. Jess' vocal chords were saved. After 18 months of trach-suctioning induced sleepless nights and occasional private duty nursing through Medicaid, Jess was successfully decanulated. Through his childhood and teen years Medicaid Home and Community Based Services (HCBS) have allowed him to build relationships and learn life skills within his community. As a result, he just graduated high school with numerous community connections and will hopefully begin work supported by a job coach paid for through Colorado's HCBS program at Cosmos Pizza or Rincon Del Sol in the fall.

Television commercials we view from the comfort of our sofas lure us to overeat high fat, high sodium, sugar, and cholesterol foods. We must find an effective way to motivate people to eat to live instead of live to eat! Keep people healthy and health care costs will drop. Regular check-ups can catch problems early and provide opportunity for educating about healthy living. Healthy people are productive people. Yet don't sentence those in need of medical care to suffer and die through neglect! I hate to say it, but I see an appalling parallel to Nazi-ism in the proposed TrumpCare plan. Instead of sending "undesirable" people to death camps directly, they will be left to starve or suffer and die of their pre-existing disease "on their own" while the government turns its back to their needs.

My family and I live in Boulder, CO. My husband, Bruce, is fully paralyzed and uses a ventilator to breath as a result of Primary Progressive MS. He has absolutely no movement below his neck. More importantly, he is a wonderful husband, my best friend, a father to 5 children (2 adopted from foster care), a stepfather to 3 children, and a grandfather to 2 amazing grandsons. Bruce is a valued member of his community. He has fostered 4 special needs foster children; showing them that fathers can be kind and patient; showing them that people with disabilities can lead productive, fulfilling lives. He often counsels newly disabled people. Bruce is a role model to adults and children with disabilities. He volunteers with our local open space and mountain parks; checking wheelchair accessible trains. He has a good life. And I love him more than life itself.

As a result of his Medicaid, Bruce employs 6 personal care attendants. He is a customer of countless medical-related businesses resulting in countless career opportunities for Coloradoans. These individuals and businesses create a significant tax base for Colorado.

My husband paid into federal and state safety net programs during his working life. He was promised that, in the event of a catastrophic illness, he would have the support of the governmental insurance programs like Social Security, Medicare and Medicaid. Now that promise is being broken. If a life insurance company reneged on their obligations after years of paying premiums, we would all be up in arms.

Block grants for Medicaid will likely reduce funding to our state. Our state will be faced with the possibility of increasing state taxes or greatly reducing Medicaid-funded services. Tabor and Gallagher will severely limit Colorado's ability to increase taxes. Tax cuts will take many years to be recouped even in a good economy. That leaves the only option of cutting services to our most vulnerable citizens – low income adults and children, adults and children with disabilities, low income seniors. It will mean lowering their quality of life; for people like my husband, it will mean that their very lives will be placed in danger; uncompensated medical care will increase dramatically; jobs will be lost; our tax base will be jeopardized.

We would urge you to reject any attempts to block grant and/or reduce Medicaid funding to states. Further, we implore you to block any attempts to reduce Medicare and Social Security. The life of my husband depends on you.

I am the mother of an adult son whose disabilities, both physical and cognitive, have qualified him for Medicaid benefits since he was a child. Medicaid programs allow him to live with his family, in the community where he grew up, and to hold a part-time job that provides important exercise outdoors and contact with friends and neighbors, in addition to a small paycheck for the limited hours he is able to work. He also benefits from traditional medical care that is covered by Medicaid, with a history of multiple heart surgeries and other conditions that require frequent treatment and life-long follow-up. In short, Medicaid allows my son to be a productive, happy member of his community, and to obtain medical care to stay as healthy as possible. He has directly benefitted from living at home, having me there to literally save his life and obtain emergency assistance when he collapsed in the bathroom from a cardiac arrhythmia. The Medicaid cuts contained the the "Better" Care Reconciliation Act could eliminate the community-based programs that allow him to live at home, resulting in institutionalization that would tear our family apart, cost my son his job and rightful place in our community, and likely reduce access to the healthcare he needs - which could directly result in his death from a cardiac event. Senator Gardner,

The latest Senate bill, as of today, states that insurers would be able to charge older customers five times more than they charge younger customers. This charge will result in an untenable decision for older members of your voting community, either pay the 5 x surcharge, or go without coverage. In effect, sign your own death warrant. Under the ACA, Medicaid is an entitlement program, with open ended matching funds from the government. The Senate proposal, would change Medicaid to funding by giving states a per capita amount or block grant, beginning in 2021. The amount would grow more slowly than in the House bill, meaning bigger spending cuts overall. Additionally, under the new Senate bill, states would not be able to expand Medicaid after three years. In states that do expand by the deadline, the federal government would pay a smaller portion of the cost starting in 2021.

If you vote in favor of passing this bill you will create a society of uninsured citizens. What does this mean;

If you order food at a restaurant, that uninsured cook fixing your food, will go to work when he or she is sick.


