My daughter is 33 years old and developmentally disabled. Medicaid is her lifeline to society.

It's not just for medical, she gets a lot of services from Medicaid that actually allow her to live in the community and be a productive member of society. My daughter lives in an assisted living facility for adults with disabilities, giving her the opportunity to live in the community like a normal person. Without the funding she receives this would not be possible. In addition, she has job coaching services and residential habilitation, all funded via the Medical Waiver program, an extension of Medicaid. Because she has job coaching services, she is able to work 3 to 4 days a week, which also cuts down on what the government pays her in disability, that's a cost savings to the taxpayers.

Not everyone on Medicaid is just working the system.

Until anyone walks a day in a parent's or guardian's shoes that has a loved one with disabilities, you will never know what it's like and how difficult life is for everyone involved.

Furthermore, if the cuts to Medicaid stay in the new health care bill, then how will my adult daughter have access to good medical care, doesn't she deserve the same care as the rest of society?

My daughter is not a second class citizen, she didn't ask to be born with part of her brain missing for no unknown explanation.

I urge you to please not cut Medicaid for those who really need it, the vulnerable ones in our society.

I pray for all of you to make the right decision.

My [grand]son, whom I adopted after he was removed from his biological parents by the child welfare system, has many challenges due to a neurological disorder similar to traumatic brain injury or Asperger's syndrome. His poor social skills, lack of judgment, executive functioning deficits, and problems with self-regulation and anger management all create tension for him in every channel of his life.

He falls between the cracks in all systems designed to help him. This means we rely on my meager salary to pay for services that are not covered by Medicaid. I am facing retirement challenges as a result and will likely need to work well into my 70's at a time in his life when he needs more services and supervision, not less.

I am aware my teen would have had to have extensive foster care services had I not raised him. It would have cost the State over \$4,000/month due to his behavior problems. I love him but there are days when I question how much I can handle. Medicaid makes it more bearable, providing mental and medical services, and medication that helps him function better.



### Hello

I am disabled and I live in New York. I have family and friends in Nevada, West Virginia, Alaska, Louisiana, Ohio, Arizona, North Dakota and Kansas who are disabled. Many receive long term supports and services through Medicaid using the Home and Community Based Services Waiver. With the proposed Better Care Reconciliation Act there are deep cuts to Medicaid, almost a trillion dollars and this will negatively impact the quality of life for me and my family/friends. Many receive supports from Direct Support Professionals (DSPs)or Personal Care Attendants (PCAs) to ensure all of our daily living needs such as getting dressed, supporting us in the classroom or at work (our jobs) and participating in many activities in our communities, the cities we live in. Without these supports we could not live at home or go to our jobs, schools or participate in ordinary things, including voting. Many of us rely on DSPs/PCAs to keep us involved and included in our community, with our friends and family as they want us including in their lives and we deserve the right support to keep us involved and included. Without this support, from real people, we would be excluded and receive Worse Care, not better care. Our lives depend on the support we receive from DSPs/PCAs in order for us to have a life, have liberty and the pursuit of happiness. If the BCRA is passed it will only result in institutionalization, we will be forced to move into nursing homes or large facilities as many politicians believe this is more affordable and more importantly many politicians do not realize that disabled people want a life and can have a life with the appropriate supports. We deserve to have the chance to work, go to school, a baseball game, vote, shop for clothing and food or drive a car...millions of us need direct support in order to have the opportunity to do these things. I urge the US Senate to speak to disabled people, especially disabled people who have made so much progress with supports through Medicaid and the Home and Community Based Services waiver. Talk to us, get to know us and listen to our life-experiences so you can learn/know we are valuable, we contribute to our communities, our families and the economy. Right now you are scaring us with this bill and how you view disabled people. Please know that Medicaid is a good resource for medical care, however it is viable and irreplaceable source for disabled people to live, just like abled-bodied people. Please hear our voices. Please listen to our experiences, knowledge and view us as valuable citizens.
