My daughter is 34 years old and mentally handicapped. My husband and I are semi-retired. Our medical insurance through my husband's work will not cover our daughter as she is over 26. BTW, that was not the case before ObamaCare. They would have covered her as long as my husband still worked there, she was disabled and lived at home. It seems many insurance companies did this when ObamaCare "raised" the limit for children living at home. It lowered the limit for those with disabilities living with their parents!!!!

Without Medicaid we would have to pay over \$800 a month for medication. My husband only brings home \$800 a month after paying insurance and taxes out of his check. She is relatively healthy other than medication for mental disability. As it is, she can't get well women OBGYN exams but she can get birth control??? She has no dental coverage so we pay that out of our pocket since dental health is linked to so many other illnesses. I would be scared to death what would happen to her if she did get sick and there was no health insurance for her. Please keep those who can't help but don't. My daughter has to prove disability to stay on Medicaid and SSI. Why is that not true for others like immigrants?

I am writing to you today on behalf of my adult son, Derek, who has developmental disabilities. Derek was born with microcephaly, which is a small head circumference in which the brain does not grow. Due to the microcephaly, Derek was diagnosed with developmental disabilities at an early age. The developmental disabilities included gross and fine motor skill deficits, as well as cognitive deficits. We were advised early on by physicians specializing in genetics, that it was unlikely that Derek would progress past the age of two years in any function in his life. We were devastated but believed that there was hope and that Derek could learn and develop with help. We have been fortunate throughout Derek's life to have the support of physicians and educators who have helped us to seek the best treatment and educational programs for Derek.

Derek is thirty-eight years old, he has Medicare and Medicaid insurance. Derek receives Social Security Disability Insurance monthly. Derek also has a Section 8 housing voucher. Derek gets a small monthly food stamp allowance.

Medicaid pays Derek's Medicare premium, and also picks up any balance that Medicare does not cover. Derek also has preexisting conditions which would be cut under the Republican Medicaid cuts. If Medicaid did not pay for services beyond what Medicare pays, Derek would have no financial ability to pay health care bills.

In addition, Derek has services through a brokerage which is funded by Medicaid. These brokerage services pay for a support person to assist Derek with activities of daily living as well as community supports. Derek lives in an apartment, but would not be able to maintain his living situation without the supports that are funded through the brokerage by Medicaid. Derek also receives an annual transit pass through the brokerage.

I am very concerned about Medicaid funding. Numerous news items have given very mixed information about changes to Medicaid, whether that be cuts in health insurance, assistance programs, brokerage services or other programs.

My son Derek, as well as many of his friends who have developmental and intellectual disabilities, rely on the assistance Medicaid provides with health related issues as well as assistance programs. These young adults cannot function independently without support.

These young adults with developmental and intellectual disabilities want to be functioning members of the communities in which they live. Living independently is a challenge. Assistance is a mandatory part of their lives in order to function to the best of their abilities. Abilities that for many that do not come naturally.

I implore legislators to improve and fund Medicaid to the fullest extent possible. There are people, like my son Derek and many of his friends, who absolutely need assistance in order to be functioning citizens.

I shudder to think of the developmental and intellectually disabled persons that would be cut off from essential services. And what of them then, who is going to make sure that they continue to live to the best of their abilities. I have a difficult time

understanding how the Republican Senators can be so callous in their thinking. Does no one in the Republican Senate have family, extended family, friends, co-workers who have a developmental/intellectually disabled adult in their lives, does no one in the Republican Senate have family, extended family, friends or co-workers with pre-existing conditions, does no one in the Republican Senate care about anyone but themselves and the almighty dollar that they can put in their pockets. Does anyone care?

My son, Derek, follows the news to the best of his ability and he is angry at President Trump and those who support his policies. Granted Derek does not fully understand all the news, but he certainly understands decency, equality and what is wrong. And in Derek's opinion cutting programs to help people like he and his friends is just plain wrong.

I implore you as a parent, advocate and guardian to rethink the values and ethics that should bind our country together. We should be looking at where help is needed, and what kind of programs need to be funded and upheld. Medicaid is a valuable program with long reaching effects. Please look into your heart and do what you know is the right thing, which is to keep funding to Medicaid intact.


