2008 FARM BILL TAX PACKAGE: FARM TAX REFORMS, FARM TAX RELIEF

Farm bill negotiators have settled on a final package of farm tax reforms funding farm tax relief, as well as agriculture and economic aid trade measures. Following is an outline of the agreement with estimated savings and costs. The agreement is fully offset.
